## Requirement Checklist:

- All applications must be received by **June 1, 2018** or they will not be considered.
- Application must be typed and completed in its entirety. Do not submit resumes.
- OFFICIAL TRANSCRIPTS must be supplied by the university registrar. Speak to the registrar's office for information on obtaining an official document. Transcript must be postmarked on or before **June 1st**.
- Eligible applicants are full-time sophomores, juniors, and seniors enrolled in undergraduate studies or students enrolled in graduate or professional degree programs. Full-time enrollment shall conform to the guidelines established by the Federal Financial Aid Program (A minimum of twelve [12] credit hours for day students or eight [8] credit hours for evening students). Part-time graduate or professional students are eligible.
- All applicants must be either United States citizens or permanent residents.
- Please provide a recent high resolution photo for marketing purposes, JPG preferred.

Make sure you checked the requirements and attach all necessary information needed to evaluate your request for a scholarship.
