RULES AND REGULATIONS OF THE POLISH ROMAN CATHOLIC UNION OF AMERICA 83rd NATIONAL BOWLING TOURNAMENT

ELIGIBILITY: Entrants <u>MUST</u> be PRCUA members in good standing as of Friday April 5, 2020. Membership will be verified by the home office.

Anyone under suspension from, or who has been refused membership in the United States Bowling Congress (USBC) is not eligible to participate.

Unmarried students under the age of 18 must have a parental consent form signed prior to competing in the tournament.

USBC membership is <u>NOT</u> required to participate in the tournament. However, this will be a USBC Moral Support Tournament, with award recognition automatically extended to members. Eligible non-members may qualify for USBC award recognition by paying associate membership dues of \$21.00 prior to the tournament. This entitles you to full USBC privileges through the 2019-2020 bowling season, which includes the 2020 PRCUA National Tournament.

EVENTS: Each event (Singles, Doubles, & Team) will consist of three games. There will be separate divisions for men and women. No mixed teams will be permitted.

Bowlers may enter each event only once. Bowlers may sign for one, two, or all three events.

No lineup changes other than substitutions will be allowed at the tournament site. Names must be listed in bowling order on the entry form.

Bowlers entering all three events are automatically eligible for all events prizes (scratch and handicap), furnished by the PRCUA. A bowler's all events score is the grand total of all nine games bowled in the tournament.

AVERAGE: A PRCUA National Bowling Tournament average will be provided by the National Bowling Director upon receipt of the participant's entry form. It is based on a minimum of eighteen (18) games over the last four (4) years.

If no tournament average exists, then the highest sanctioned league average (Yearbook average) from the 2018-19 season based on a minimum of 21 games must be provided by the participant. Bowl.com average will be recognized as the official source.

If the participant does not have a Tournament or 2018-19 Yearbook average, the following conditions will apply, in order:

- 1. Highest League Average (Yearbook) as of May 31, 2018.
- Current 21 game League Average as of SIX days prior to this tournament. (An official league average sheet must be presented to tournament director 45 minutes prior to start of event time).
- 3. Highest League Average (Yearbook) as of May 31, 2017.
- 4. Highest League Average (Yearbook) as of May 31, 2016.

If no previous scores are available (or the minimum tournament scores on record is not met), you will be given the default average of 165 for men and 135 for women.

Each entrant is responsible for the accuracy of their average whether submitted by captain or others. Correction of an average must be made by the end of the first game of any event. Falsification of an average will result in disqualification if submitted average is lower than correct average. If submitted average is higher than correct average, prize winnings will be

members in good based on submitted average. Tournament management will be verified by reserves the right to correct any averages and adjust final tournament standings accordingly.

Sports bowlers must comply with USBC Rule 202 regarding average adjustment.

USBC Rule 319c regarding average re-rating will apply to all entrants. USBC Rule 319d regarding the reporting of prior tournament prize has been waived and will not be in effect. USBC Rule 319a-2 (10 or more pins over previous year's average) will not be in effect.

HANDICAP: Handicap will be 80 % of the difference between the bowler's average and 220. Team handicap will be the sum of the individual handicaps.

PRIZES: The prize fee portion of the entry fee will be returned 100%. At least one cash prize will be awarded for every five entries. In addition, the PRCUA and/or the host bowling center may furnish merchandise prizes.

Only one prize for series will be awarded to a team or individual in each event. If a series qualifies for both a scratch and handicap prize, the larger prize will be awarded. The scratch prize will be awarded in the case of equal prizes.

A cash prize of \$1,500.00 will be awarded to the first person to bowl a 300 game in the team event. Two or more bowlers with a 300 game in the same game will split the cash equally. Scores of 300 in the same game will be considered simultaneous, regardless of squad time or who is the first to finish.

ENTRIES: Entries close Friday, March 20, 2020, and must be postmarked by Friday, March 20, 2020. The total entry fee must accompany the entry form. No entry fees will be returned after the closing date.

SCHEDULE: Every effort will be made to assign bowling times according to preferences indicated on the entry forms. A schedule listing the assigned times will be posted online at **www.prcua.org** and available at the tournament site.

Tardy bowlers will start in the frame being bowled with zero being given for each frame missed. This rule may be waived by the tournament director in cases of emergency.

<u>CHECK IN</u>: A representative from each team must check in at the tournament office at least 30 minutes prior to the assigned bowling time in the team event. No checkin is necessary for the doubles/singles squads unless there are questions on averages.

TOURNAMENT MANAGEMENT: The tournament director, Valerie Brumm, is responsible for all technical aspects of the tournament, including resolving all disputes according to tournament or USBC rules.
