  - Applicants must be either United States citizens or permanent residents.
    - Please provide a recent high-resolution headshot for marketing purposes (min. 300 dpi); JPG preferred.

Incomplete applications will not be considered or returned. Awards will be mailed directly to recipients for delivery to educational institution.
