## FORMER PRCUA CHAPLAIN **REV. CANON ANTHONY D. IWUC PASSED AWAY**

It is with sadness that the PRCUA must announce the passing of its beloved National Vice Chaplain, Rev. Canon Anthony D. Iwuc, at the age 93, on March 30, 2021. He went to his heavenly reward after being hospitalized for a week. Fr. Iwuc wholeheartedly served the Lord as a devoted priest for 67 years. Likewise, he enthusiastically served the PRCUA for 47 years as national chaplain from 1974 to 1986 and as national vice chaplain from 1986 to


Fr. Iwuc faithfully attended the PRCUA National Conventions, as well as its annual Sacred Heart Mass,

special commemorations and celebrations. Known for his gentle nature, wonderful sense of humor and personal charm, Father Iwuc enriched the PRCUA with his humble service and wise counsel. He will be joyously remembered for his melodious voice, which he often used to lead PRCUA members in singing old tunes that brought back memories of the "good old days." He also wrote a column in the Naród Polski newspaper for many decades. The PRCUA officers, board and members are most grateful for the half-century of spiritual leadership that Fr. Iwuc so graciously dedicated to our fraternal.

Born in South Attleboro, MA, Father was the 7th of 10 children of Bronisław and Adolfina (Zamoida) Iwuc. He was predeceased by his brothers, Frank, Joseph, Stephen and Edward and his sisters Stella, Lottie, Jane and Jessie. He is survived by his brother, Charles Iwuc of South Attleboro, MA and several nephews and nieces.

Anthony Iwuc was educated in Attleboro Public Schools, St. Joseph School in Central Falls, St. Raphael Academy in Pawtucket, RI., Our Lady of Providence Seminary, RI and St. Mary's College, Orchard Lake, MI. He was ordained on May 30, 1953 by Bishop Russell J. McVinney.

Fr. Iwuc was proud of his Polish heritage and demonstrated it by actively participating in Polonia. The annual Pulaski Day Memorial was organized by Fr. Iwuc at Roger Williams Park in Providence, RI, as well as the annual Polish parish festivals. In the 1980s, when Poland was under martial law, Fr. Iwuc worked tirelessly with the Polish American Congress Charitable Foundation to coordinate donations throughout northeastern U.S.A.



Fr. Iwuc's other memberships included: Polish National Alliance, Polish American Historical Association, Kosciuszko Foundation, Polish-Hungarian World Federation and Affiliation, Polish American Guardian Society, Catholic League for Religious and Civil Rights, Knights of Columbus (4th Degree), John

Paul II Foundation of New England and the American-Polish Cultural Exchange Commission.

Fr. Iwuc was devoted to the Blessed Mother and promoted recitation of the Rosary throughout his life. His priestly ministry included service as administrator of Our Lady of Czestochowa Church in Coventry, RI (1953 to 1972), where he organized the construction of its school. He was pastor of his home parish, Saint Joseph's in Central Falls for 33 years (1972-2005), where he renovated the interior of the church, purchased its new organ and established the St. Joseph's Church Parish Center. In his retirement, he lived at St. John Vianney Residence in Providence, RI, where he served local parishes.

The leadership roles that Fr. Iwuc fulfilled include: president of the Rhode Island Division of the Polish American Congress since 1972; Orchard Lake Schools Summa cum Laude member of the Chancellor's Senate, Board of Trustees, Board of Regents, national president of the Orchard Lake Schools Alumni Association and as founder and moderator of the Orchard Lake Schools Ladies Auxiliary. He was a member of the Polish American Priests Association, where he served on the Board of Directors and as a past vice president.

Fr. Iwuc was also a member of the Board of Directors of the Polish Museum of America and the Commission on Religious Affairs of the Polish American Congress. Fr. Iwuc served the Diocese of Providence as a member of its Liturgical Commission; Commission for Clergy Renewal; Marian Commission; Director of the Holy Name Society; Council of Priests; College of Consultors; Continuing Education of the Clergy; Executive Committee (*Cont. on pg. 7*)

# PRCUA 2021-2022 SCHOLARSHIP INFORMATION

Economic conditions in the United States and throughout the world, as well as an ever more competitive job market, have made the need for an undergraduate, graduate, or professional degree a virtual necessity for today's student. At the same time, the higher costs of education pose a serious and challenging barrier to students and their families to bear. The PRCUA recognizes the necessity of assistance for students of the Polish American community and has developed several financial vehicles to aid in the pursuit of undergraduate and graduate degree programs.

During the 2021-2022 school year, the PRCUA will offer two types of scholarships. The PRCUA Education Scholarship is open to all who apply, whereas the PRCUA Fraternal Scholarship is open exclusively to members of the PRCUA. Students can apply for each scholarship once annually, but they may receive only three awards of each scholarship during their lifetime. Scholarships are specific to the school and educational program named in the application. The deadline for submitting applications is June 1, 2021.

PRCUA Education Scholarships totaling \$20,000 are awarded to students based on the number of applications submitted and are available to all students, even those who are not members of the PRCUA. Scholarships will be awarded in amounts ranging from \$500-\$2,000.

- 1. Applicants must have successfully completed their freshman year of undergraduate studies before the deadline for filing an application. An official transcript or other documentation from the applicant's school must be sent directly by the educational institution by mail or electronically to the PRCUA on or before the deadline of June 1.
- 2. Eligible applicants include sophomores, juniors, and seniors enrolled full-time in undergraduate studies or those students enrolled in a graduate or professional degree program. Full-time enrollment shall conform to those guidelines estab-

lished by the federal financial aid program: a minimum of twelve credit hours for day students or eight credit hours for evening students. Part-time graduate students are also eligible.

- 3. Applicants must have a cumulative grade point average (GPA) of 3.0 or better on a 4.0 scale or 4.0 or better on a 5.0 scale.
- 4. All applicants must be either citizens or permanent residents of the United States.

The PRCUA Fraternal Scholarship is available to eligible PRCUA members. For the 2021-2022 school year, the PRCUA will award scholarships totaling \$25,000, in amounts ranging from \$500-\$2,000. These scholarships are open to all current PRCUA members. Applicants must fulfill all the requirements listed above AND be a member of the PRCUA for a minimum of five years AND have an active certificate of a minimum of \$5,000 (and must be current with its payments).

The following options are available to applicants who do NOT fulfill the above five-year requirement:

- Three-year membership with the PRCUA holding a \$25,000 certificate or
- Four-year membership with the PRCUA holding a \$15,000 certificate

Note: Applicants must have active certificates and be current with their payments for five years after receipt of the final scholarship.

Selection of award amounts and recipients will be made by an independent committee of jurors. For both scholarships, awards will be granted to applicants based on the highest number of points earned, including an essay (in English).



# NEW ENGLAND FRATERNAL ALLIANCE 2021 SCHOLARSHIPS

Award: Two \$1,000 scholarships will be awarded by the New England Fraternal Alliance to students in their sophomore, junior, or senior year in college or in graduate school. The first is named in memory of Pearl Plante, a loyal and tireless worker for the New England Fraternal Alliance; the second is named in memory of Normand Ouellette, a past president and heart of the Alliance.

**Eligibility:** Applicant must be enrolled as a full-time student in an accredited college/university or graduate school.

Applicant must be a resident of New England and a member (or a son /daughter of a member) of a fraternal benefit society that holds a membership in the New England Fraternal Alliance.

Applicant must have a cumulative grade average of at least 2.0 (on a 4.0 system). Transcript of grades from spring 2021 semester must be submitted with application.

Application for scholarship award must be completed in its entirety and submitted by **September 1, 2021**. Incomplete and/or late entries will be disqualified. There will be absolutely no extension of the deadline.

**Procedures:** The \$1,000 scholarship awards will be paid directly to recipients.

Criteria to be used in judging: overall merits of applicant, cumulative grade average, college activities/ honors, community activities, financial need and essay content.

From among the entries, top ten applications will be selected and referred to a three member panel for final judging. Recipients of NEFA scholarship awards will be notified by October 15, 2021.

## LIFE INSURANCE: QUESTIONS AND ANSWERS

Life insurance in times of the coronavirus pandemic

At a time when the COVID-19 pandemic has disrupted our lives by making it difficult to access offices, stores, pharmacies, schools and restaurants, simple activities seem not to be so simple anymore. In Illinois, all federal offices are still closed to clients. The orders to wear a mask and keep social distance are still in force

Although everyone is at risk of infection of the virus, those people whose immunity is compromised and the elderly are at greatest risk of serious complications that may even require hospitalization. Treatment can be prolonged, painful and expensive. Increasingly, we come to the conclusion that the question we should be asking is not whether we will get sick, but when. We may be worried about what would happen to our family when the unexpected happens... how would they cope with everyday life, with payments, with funeral costs?

The solution to these problems may be to purchase a life insurance policy. But is it still possible now?

The answer is YES.

Many insurance companies have made it easier to purchase a policy with an agent remotely, i.e. by phone, tablet or computer. An inperson meeting with the agent is no longer necessary. We can both fill out and sign the policy electronically at the same time we are talking to our agent over the phone.

We often wonder how to choose the right face amount of the policy based on our needs. At first glance, it might seem that a basic \$50,000-\$100,000 policy should be sufficient, but in

most situations, a more personalized solution is required. When working with an agent, we should conduct a needs analysis, which will allow us to more accurately define our needs in order to ensure the normal functioning of our family in the event of our death.

What should we consider? How do we correctly calculate the amount for which we should protect ourselves and our families?

The amount of the policy should definitely depend on our financial capabilities. Buying a life insurance policy does not necessarily involve a one-time payment. It may, in fact, be a long-term commitment. The amount that we pay is determined at the time of issue of the policy, and its maintenance depends on the continuity and reliability of the person responsible for payments.

When calculating the amount of the policy, we should also take into account the change in prices and services over time (inflation). Unfortunately, costs in ten or twenty years will not be the same as those of today. For example, on average, burial prices double every 10 years.

## Moving on to the calculations. What do we need to consider?

First, we need to calculate the amount of our debt, including the amount owed on a mortgage, car, school loans, credit card debt and so on.

Now let's add the cost of our children's education. The cost for educating a child can be close to \$400,000. Multiply this amount by the number of children or grandchildren we would like to take care of.

Next, evaluate how much it costs to maintain our current standard of living. How much do we spend on food, clothes, utility bills and incidentals? On average, it is suggested that we use 5-10 times the amount calculated above to ensure the current standard of living of our family for a number of years.

Let's now add double the current estimated funeral costs, which are currently between \$15,000 and \$20,000, to ensure the cost (*Continued on pg. 9*)

Among the awards that Fr. Iwuc received are: the first "Man of the Year" Award, Loyalty Plaque and Fidelitas Medal from the Orchard Lake Schools, Polish National Alliance Certificate of Merit Award, and the Cavalier Cross Medal from the Republic of Poland.

A concelebrated Mass of Christian Burial was

held on April 8th at St. Joseph's Church in Rhode Island. President James Robaczewski was in attendance to represent the PRCUA and Chaplain Rev. Canon Walter Ptak delivered the homily.

May Fr. Iwuc be blessed a hundredfold for all the good he did for others throughout his life and may he rest in the hands of God.

## LEADERS OF THE POLISH ROMAN **CATHOLIC UNION OF AMERICA** PETER KIOŁBASA

Peter Kiołbassa (pol. Piotr Kiołbassa) was a U.S. Army captain, politician, Chicago Treasurer and Commissioner of Public Works, Polish American activist, and one of the organizers of the Polish Roman Catholic Union of America.

Peter Kiołbassa was born on October 13, 1837 in the village of Schweiben, Silesia, Prussia (at present Świbie in Silesian Voivodeship in southern Poland). He was the son of Stanislaw and Franciszka (Burda) Kiołbassa. His father was a prominent man and was a member of the first German parliament from 1848 to 1849. The Kiołbassas came to the United States on December 2, 1854, when Peter was 17 years old. In 1855, the family settled in Panna Maria, TX, where only one year earlier the first Polish settlement in the United States was founded.

In Poland, Peter received elementary and high school education, studied music, and became a piano player. He spoke Polish, German, French and Bohemian from his youth, and learned English and Spanish while living in Texas.

In 1857, Peter became the first teacher and organist in Panna Maria. Before a proper schoolhouse was built, classes were held in the barn.

In 1858, Stanisław Kiołbassa decided to move out of Panna Maria because of the unhealthy conditions in the settlement. The family settled briefly on a farm near Castroville, TX, then moved to San Antonio, TX the same year.

In 1859, Peter was employed as a store clerk in Piedras Negras in Mexico, where he perfected his Spanish and acquainted himself with commerce. That same year, he took an examination for a teacher's license and taught at intervals in Panna Maria until 1861.

On April 12, 1861, the American Civil War began. On October 9, 1862, Peter Kiołbassa enlisted in the Confederate Army as a private in the 24th Texas Cavalry. After he was captured and taken prisoner in one of the battles in 1863, he was recruited by the Union Army. First, he was promoted to the rank of sergeant, then to sergeant major. On January 5, 1865, Kiołbassa was commissioned an officer and placed in the command of the African American Unit as the captain of the Sixth Colored Cavalry. He fought in battles at Knoxville, Atlanta, Nashville, and many others.

While he was still in the service, Peter spent two months in 1864 on a furlough in Chicago. During his stay in Chicago, he helped to organize the first local Polish Society of St. Stanisław Kostka. Its goal was to provide help to Polish Catholics in America in the name of fraternal

In October 1965, Kiołbassa returned to Chicago and married Pauline Dziewior. Pauline was 17, Peter was 27. The couple had one daughter Rosa, born in 1873 (a pianist and opera singer who later married another Polonian leader and PRCUA activist Franciszek Kwasigroch.)

Kiołbassa was discharged from the Army with honors in May of 1866. He settled with his wife in Chicago where he began building his career and became a recognized leader of the Polish American community.

He played a major role in reorganizing the St. Stanisław Kostka Society in 1866, of which he became the president. (All the cofounders and leaders of the society became later the cofounders and leaders of the PRCUA.)

In 1866, Peter opened a grocery store on 124 Wesson St. (which was later renamed to Cambridge St.) but operated the store only for a few months.

In 1867, he entered the Chicago police force. Because of his polyglot abilities and excellent handwriting, after six months, he advanced to desk sergeant and then secretary to the chief of police.

In 1867, he helped organize the Roman Catholic Parish of St. Stanislaus Kostka in Chicago (finished in 1869), which later became the largest Polish parish in the U.S.


In 1869, Kiołbassa took a leave of absence from his police duties and went to Panna Maria, TX where he worked as a teacher and organist for two years, and as a postmaster for one month.

He returned to Chicago and to his old position in the police department in July 1871. In 1873, he was nominated the deputy sheriff. On March 24, 1873 he became the clerk at the Chicago Federal Custom House where he remained for the next 14 years.

In October 1873, the leaders of Polonia met in Detroit, MI and founded Union of Polish Catholics. Kiołbassa, together with representatives from Pennsylvania, New Jersey, New York, Rhode Island and Indiana were elected the leaders of the newly formed organization. In October 1874, the organization adopted the name Polish Roman Catholic Union of America. Kiołbassa was elected vice president. He was elected and reelected as PRCUA president from 1880 to 1885, and then from 1889 to 1892.

Over the next 30 years, Kiołbassa was one of the most eminent leaders of the Polish American community and the PRCUA, serving as a member of different committees and boards of the organization and representing the PRCUA and Chicago Polonia at many events.

He was one of the founders of the Polish Publishing Company (Spółka Wydawnictwa Polskiego) in Chicago (its main goal was to strengthen Catholic press through new publishing houses.) The company was composed of: Fr. Vincent Barzyński, Fr. Jan Radziejewski, Peter Kiołbassa, Wojciech Jedrzejek, and other priests and civilians. They

published Wiara i Ojczyzna (from May 3, 1887) and Kropidło (from June 24, 1887). Wiara i Ojczyzna replaced Gazeta Katolicka as the official organ of the Polish Roman Catholic Union of America.

He was a member of the Orphanage Foundation Committee, Committee of PRCUA Incorporation, the PRCUA Constitution Revision Committee, and the chairman of several PRCUA conventions. He belonged to numerous PRCUA Societies and for some time was the Honorary PRCUA President (the title was abolished in the past.)

At the 16th PRCUA Convention in October 1889 in Bay City, MI, Kiołbassa was elected a delegate to the First Catholic Congress in the United States on November 11-12, 1889.

He was elected the chairman of the 100th anniversary of the Constitution of May 3, 1891 celebration at St. Stanislaw Kostka Hall.

Kiołbassa was the grand marshal of the a few parades held in Chicago on the occasion of significant anniversaries: the 50th anniversary of the Polish November Uprising (1830) on November 29, 1880; the 200th anniversary of Sobieski's victory at Vienna (1683) on August 23, 1883; joined celebration of the 400th anniversary of the discovery of America (1492) and the inauguration of the Columbian Exposition in Chicago on October 20, 1892 (on the day preceding the official dedication of the world's fair); and the 100th anniversary of the (Continued on pg. 9)

Kosciuszko Uprising (1794) on May 3. 1894 r.

Kiołbassa was the initiator of the construction of the Polish Pavilion for the 1893 Columbian Exposition. On October 7, 1893, a Polish Day was held. During the world's fair, the Polish community organized a banquet in honor of Kiołbassa.

In March 1893, Kiołbassa and other Polonia leaders signed The Polish Memorial expressing their dissatisfaction with the treaty between the U.S. government and Russia on the mutual rendition of offenders (participants of the January uprising who fled to America, were also considered criminals by the Russian government.) Kiołbassa was received at the White House and presented the memorial personally to President Cleveland.

In 1894, the PRCUA passed a resolution to participate in the General National Exhibition (Powszechna Wystawa Krajowa) on the occasion of the 100th anniversary of the Kościuszko Uprising in Lviv. Kiołbassa was appointed one of the delegates to the exhibition and vice president of the Central Committee of American Polonia Participation (Komitet Centralny Udziału Polonii Amerykańskiej) at the exhibition.

On May 8, 1894, he was the chairman of the Polish Rally (Wiec Polski) in the St. Stanisław Kostka Hall in Chicago. The rally gathered for the purpose of creating the Polish League in America (Liga Polska w Ameryce.)

Kiołbassa was elected vice marshal of the 1st Polish Catholic Congress, held in September 1896 in Buffalo, NY.

Shortly before the Spanish-American war was formally declared on April 21, 1898, Kiołbassa began to organize a Polish regiment in Chicago. The recruitment station was located in his office at 113 W. Division Street.

Kiołbassa combined his leadership in Polonia and in the PRCUA with a civil and political career. Shortly after coming to Chicago, he engaged in real estate, the fire insurance business, and had a notary public office. He was the first Pole to succeed in local politics.

In 1877-78, Kiołbassa was a member of the House of Representatives of Illinois.

In 1888, he ran as a Democrat for alderman of Chicago's 16th Ward but lost to Republican August Kowalski.

In 1891, the Democratic Party nominated Kiołbassa as a candidate for city treasurer. He won by receiving 50,056 votes (5,000 more than his opponent), and served as city treasurer from April 1891 to May 1893. He received the nickname "Honest Pete" - Kiołbassa was the first city treasurer to return the interest (about \$42,000) on the city funds to the treasury. Previously, the interest on public funds was the private perquisite of the holder of the office.

Kiołbassa was encouraged to run for governor of Illinois after his term as treasurer but he did not believe the state would vote for a foreignborn governor.

In 1898, he was elected the alderman, narrowly defeating John F. Smulski.

In 1901, Peter's first wife Pauline died. He married his second wife Antonina Otzenberg in 1903.

In 1902, Kiołbassa was nominated building commissioner and in 1904, he became the commissioner of public works.

Peter Kiołbassa died on June 23, 1905 at his home at 625 N. Milwau-

Initially, he was a member of the Republican Party and later switched his affiliation to the Democratic Party, but he was highly respected by both Republicans and Democrats. After his death, Chicago City Council passed a mourning resolution and all city hall offices were closed in sign of mourning. Kiołbassa was considered "the most famous, respected, and popular Catholic in the Chicago archdiocese." Thousands of people attended his funeral, including members of the City Council with Mayor Edward F. Dunne at the helm, veterans from the Grand Army of the Republic, representatives of the police regiments, branches of Polish societies, representatives of various organizations, including the PRCUA Administration and many PRCUA members.

The funeral Mass was held in St. Stanisław Kostka Church and was celebrated by the suffragan Bishop Muldoon in the presence of Archbishop Simon. The funeral speech was delivered by Fr. Władysław Zapała, C.R.





Just as the plants and flowers peek through into the sunlight of spring, so do we, as we continue on our journey into the new normal. May is here and with it our beloved celebrations and traditions including honoring our Blessed Mother Mary, our mothers, our Motherland, and those who gave their lives for our homeland. We applaud the graduates, pray with the first communicants and support accomplishments of our performers.

So where do we begin? On May 1st, of course! In Poland, the first weekend in May is called "Majówka" – it starts with International Workers' Day (5/1), Polish National Flag Day and Polonia Day (5/2) and ends with Polish Constitution Day (5/3). The May 1st holiday, also referred to as May Day or International Labour Day, is not unique to Poland alone. In fact, it honors the strength, commitment, and achievements of the working class's... raising concerns about forced labor, regulation of minimum wage, the rights of migrant workers, etc. and promoting international labor associations as well as local unions and groups. Many of us, particularly the working class, are unaware of the significance

of May Day, and yet we reap the benefits because of it, including an eight-hour workday. May Day was officially recognized as a public holiday by the Second International Congress in 1891. Although the United States and Canada celebrate Labor Day on the first Monday in September, 80 other countries celebrate on the first of May.

This year, the Polish Constitution of 1791 celebrates its 230th anniversary. This historical document "combined a monarchic republic" with three divisions of power: executive, legislative and judicial and was the first of its kind in Europe and second in the world, as the United States Constitution was implemented in 1789. Note that even in the 13th century, traces of Polish constitutionalism were found where agreement and representation governed in the young Polish state. During the first half of the 16th century, the "sejm" and "sejmiki" evolved. "By the 17th century, Poland's legal and political tradition was characterized as parliamentary institutions and a system of checks and balances on state power, which was itself limited by decentralization. The system of a contractual state; the concept of individual liberties; and the notion that the monarch owed duties to his subjects primarily benefited the Polish nobility (szlachta), came to be known as the nobles' democracy." In lieu of the grand Polish Constitution Day Parade down the streets of Chicago on the first Saturday in May, there will be a virtual commemoration with additional celebrations such as the annual Mass at Holy Trinity Polish Mission hosted by the PNA, a wreath-laying ceremony at the statue of Thaddeus Kościuszko in Chicago's Museum Campus, a program presented by the PRCUA Polonia Ensemble under the direction of National District 7 Director Anna Krysinski at St. Ferdinand's parish, a Polish flag-raising ceremony at Daley Plaza and a special

program at the Polish Consulate where Anna Krysinski and Mieczyslaw Dzis will be awarded the Bronze Medal for Culture "Gloria Artis." In addition to the aforementioned events, the Consul of the Republic of Poland in Chicago, Małgorzata Bąk-Guziak, is to honor three Polish-American veterans at a military promotion ceremony on Friday, April 30, at the Polish Museum of America. Details in next month's issue of the Naród Polski.

In light of the restrictions of last year's gatherings, as 2021 Mothers' Day draws near - May 9th in the U.S. and always May 26 in Poland - most of us will be thrilled just to be with our families. Cleveland, OH Lenten rigors, in every way imaginable, what more could be asked for than to welcome the Resurrection of our Lord - especially at Polish parishes where that Easter Joy seems so much more tangibly real... after all, nothing says "CHRIST IS RISEN" better than a hunk of smoked kielbasa!!! As of this writing, we are barely half-way through this enriching time. Be sure to do your part to ensure that the celebration of our Lord's resurrection surpasses that of our preparation for it!


In a special way, though, our Easter Joy has been made even greater. Perhaps it is because I sit on the Administrative Board of the Pope John Paul II Foundation in Rome and that I was made responsible for this particular leg of the journey, but we became the first parishes in the State of Ohio to welcome the internationally traveling Centennial Triptych of St. John Paul II. The Triptych was commissioned by the Foundation in Rome to honor the 100th anniversary of the birth of its saintly founder, St. John Paul II. In addition to his image, it also features images representing two of the most important aspects of his personal devotion and pontificate: Our Blessed Mother, Mary, represented by an image of Our Lady of Czestochowa, and the Divine Mercy, represented by an image of St. Faustyna with our Merciful Savior. The Triptych tours accompanied by two first class relics in beautiful reliquaries: that of St. John Paul II and St. Sr. Faustyna Kowalska.

Beginning on the Feast of Divine Mercy, the Triptych was the focal point for a Parish Recollection at our Shrine Church focusing on the themes of the rich teaching of St. John Paul II, the place of Maria devotion in his life and pontificate and the life of the Church, and the richness of Divine Mercy in the life of St. Faustyna and the Church. During this time, we made available to the people various devotional items, offered the relics for veneration, as well as prayed the Novena to St. John Paul II and the Litany of St. John Paul II. The Triptych has since moved on to my second parish, Historic Saint Casimir's, and from there will continue on to visit other parishes in the Cleveland Diocese and throughout the State of Ohio before moving onward.

When an icon goes "on tour", there is a special term applied for its journey: a PEREGRINATION. This icon has already visited a number of places, most recently in Canada around the Windsor area and then in the Detroit area. It had also toured parts of the eastern United States and other parts of Canada just before then. But why such a visit and "tour"?

Just as the rich and still ever-fruitful pontificate of St. John Paul II has taught us, it is necessary from time to time to remind people of the importance of certain foundational teachings and beliefs. When he "burst" upon the scene as Pontiff in October of 1978, the world was ripe to hear his message of "be not afraid", of the dignity of the human person, and of the meaning of truth, etc. His long pontificate which contributed such rich teachings with such meaningful accomplishments (they are far too many to list but there are now universities offering doctorate degrees in St. John Paul II studies and in just certain aspects of his teaching, as well) will take a century for their meaning to be fully unpacked and appreciated.

Sadly, our present day is another one of those times in need of being reminded. We almost continuously see on the news the evidence of what happens when the current day's trend or yesterday's error replaces the triedand-true beliefs upon which our society - and civilization - are built. The

Peregrination of the Pope John Paull II Triptych gives those where it visits a chance to be reeducated, recharged, strengthened in their grasp of the Truth, and emboldened to live out their faith in what seems to be an ever-increasingly hostile environment.



Na potrzeby dyżuru konsularnego Mount Prospect, PSFUK udostępniła swoje pomieszczenia nieodpłatnie.

Konsulowie specjalnie wydelegowani przez Ministerstwo Spraw Zagranicznych do czasowego wsparcia konsulatu w Chicago będą w dni robocze (od poniedziałku do piątku) przyjmować dziesiątki wniosków paszportowych dziennie.

Dodatkowo z dniem 6 kwietnia konsulat otwiera kolejne stanowisko do przyjmowania wniosków paszportowych w urzędzie.

Ostatni poniedziałek maja jest obchodzony w USA jako Dzień Pamięci czyli Memorial Day. W tym dniu wspominamy żołnierzy amerykańskich poległych na różnych frontach, w różnych zakątkach świata. Święto znane wcześniej jako Dzień Dekoracji (Decoration Day), początkowo obchodzone było ku czci żołnierzy Unii poległych w wojnie secesyjnej. Później święto to przekształciło się w honorujące wszystkich, którzy zginęli w amerykańskiej służbie wojskowej. Od 1868 roku Dzień Pamieci celebrowany był 30 maja. W 1971 r. na mocy ustawy Kongresu USA z dnia 28 czerwca 1968 r., Memorial Day został przeniesiony z 30 maja na ostatni poniedziałek maja.

Ubezpieczenia na życie w czasach pandemii COVID-19

W czasach, gdy pandemia COVID-19 dezorganizuje nasze życie utrudniając dostęp do urzędów, sklepów, aptek, szkół i restauracji stresującymi stają się wydawałoby się proste czynności. W stanie Illinois nadal wszystkie biura federalne są zamknięte dla petentów. Wciąż obowiązuje nakaz noszenia maseczki i dystans społeczny.

Na zakażenie wirusem jesteśmy narażeni wszyscy, ale osoby o obniżonej odporności i osoby starsze są najbardziej zagrożone poważnymi komplikacjami i mogą wymagać hospitalizacji. Leczenie może być długotrwałe, bolesne i kosztowne. Coraz częściej dochodzimy do wniosku, że poprawnym pytaniem jest nie, czy zachorujemy, lecz kiedy. Martwimy się co stałoby się z naszą rodziną w momencie jakby nas zabrakło. Jak poradzą sobie z życiem codziennym, z płatnościami, z kosztami pogrzebu?

Rozwiązaniem powyższych problemów może okazać się wykupienie polisy na życie. Ale czy teraz jest nadal możliwe?

Okazuje się, że tak.

Wiele firm wprowadza ułatwienia pozwalające na wykupienie polisy z agentem w sposób zdalny tzn. przez telefon, tablet lub komputer. Osobiste spotkanie z agentem nie jest już niezbędne.

Możemy wypełnić polisę elektronicznie i w ten sam sposób ją podpisać rozmawiając jednocześnie z agentem przez telefon.

Często zastanawiamy się jak dobrać wysokość polisy do naszych potrzeb. Na pierwszy rzut oka wydawałoby się, że przysłowiowe \$50,000-\$100,000 powinno spokojnie rozwiązać sytuacje. Niestety w większości sytuacji to tylko pozory. Rozmawiając z agentem powinniśmy dokonać tak zwanej analizy potrzeb (needs analysis). Analiza ta pozwoli określić w bardziej dokładny sposób potrzeby, które powinniśmy zabezpieczyć, by zapewnić normalne funkcjonowanie naszej rodziny w sytuacji, kiedy nas zabraknie.

Co powinniśmy wziąć pod uwagę? Jak wyliczyć poprawnie kwotę na jaką powinniśmy się zabezpieczyć?

Wysokość polisy powinna zależeć na pewno od naszych możliwości finansowych. Wykupienie polisy na życie najczęściej nie wiąże się z jednorazową opłatą, a raczej ze zobowiązaniem długoterminowym. Kwota, którą będziemy płacić ustalana jest w momencie wystawienia polisy, a jej utrzymanie zależy od ciągłości i rzetelności ubezpieczonego.

Wyliczając kwotę zabezpieczenia powinniśmy również wziąć pod uwagę zmianę cen i usług w czasie, czyli krótko mówiąc inflację. Niestety ceny za 10 lub 20 lat nie będą podobne do dzisiejszych. Na przykład ceny pochówku dublują się statystycznie średnio co 10 lat.

Przejdźmy do wyliczeń. Co wziąć pod uwagę?

Po pierwsze zsumujmy kwotę naszego zadłużenia. Dodajmy wysokość pożyczek hipotecznych, samochodowych, szkolnych, kwotę obciążenia kart kredytowych i itp.

Policzmy koszty edukacji naszych dzieci. Wykształcenie jednego dziecka może wiązać się z kwotą zbliżoną do \$400,000. Pomnóżmy tą kwotę przez ilość dzieci lub wnuków, o których edukacje chcielibyśmy zadbać.

Sprawdźmy, ile wynoszą koszty utrzymania obecnego poziomu życia. Ile wydajemy na jedzenie, ubrania, świadczenia i drobne przyjemności. Średnio utrzymuje się by użyć 5-10 krotności powyższej kwoty do zapewnienia obecnego poziomu życia naszej rodziny na kilka lat.

Dodajmy dwukrotny, obecny szacunkowy koszt pogrzebu, który obecnie wacha się pomiędzy \$15,000, a \$20,000 tak by zapewnić realność powyższej kwoty w przyszłości.

Na koniec dodajmy kwotę, którą chcielibyśmy przekazać bliskim jako pamiątkę po nas.

Jak widać po zsumowaniu powyższych kwot może okazać się, że początkowe \$50,000-\$100,000 nie wystarczy. Pamiętajmy, że każda sytuacja jest indywidualna i polisy powinny być zawsze dostosowane do potrzeb i możliwości ubezpieczonego. Warto porozmawiać z agentem specjalizującym się w zabezpieczeniu zdrowia, życia i przyszłości by wziąć pod uwagę pełne spektrum potrzeb i odpowiedzialności.

## 230. ROCZNICA UCHWALENIA **KONSTYTUCJI 3-MAJA**



Uchwalenie Konstytucji 3 Maja 1791 roku, Jan Matejko, olej na płótnie (1891)

Już od początku XVIII w. w Polsce powstawały rozmaite idee głębokich reform politycznych. Intelektualiści krytykowali ustrój oparty na zasadzie liberum veto i słabości władzy wykonawczej oraz proponowali nowe sposoby sprawowania rządów w Rzeczpospolitej.

3 maja 1791 r. Sejm Czteroletni (obradujący w latach 1788–1792) przyjął regulującą ustrój prawny Rzeczypospolitej Obojga Narodów Ustawę Rządową, która do historii przeszła jako Konstytucja 3 maja.

Autorami Konstytucji 3 maja byli król Stanisław August Poniatowski, Ignacy Potocki, marszałek wielki litewski i działacz polityczny oraz Hugo Kołłątaj, działacz i pisarz polityczny, organizator nauki i oświaty, filozof i ksiądz.

Konstytucja 3 maja była pierwszą nowoczesną liberalną spisaną konstytucją w Europie i drugą na świecie (po Konstytucji Stanów Zjednoczonych z 1787 r.). Ustawa Rządowa została zapisana w 11 artykułach, które poprzedzał uroczysty wstęp (preambuła). Wprowadzała ona trójpodział władzy: na ustawodawczą, wykonawczą i sądowniczą. Władzę ustawodawczą posiadał dwuizbowy parlament, w skład którego wchodziła Izba Poselska (204 posłów ze szlachty ziemiańskiej i 24 plenipotentów reprezentujących miasta królewskie) oraz Izba Senacka (132 członków - senatorowie, wojewodowie, kasztelani, ministrowie oraz biskupi). Władza wykonawcza należała do Staży Praw na czele z królem. Władzę sądowniczą stanowiły sądy - odrębne dla szlachty, mieszczan i chłopów oraz Trybunał Koronny.

Ponaddto Konstytucja 3 Maja wprowadziła szereg innych uchwał, m.in.: naród uznano za suwerena kraju; zniesiono wolną elekcję (wybór monarchy nieprzestrzegający zasad sukcesji dynastycznej); zniesiono liberum veto (prawo zrywania obrad sejmu wskutek protestu jednego posła); zniesiono podział na Koronę i Księstwo Litewskie; pozbawiono szlachtę prawa najwyższej zwierzchności nad poddanymi; ustanowiono dziedziczną monarchię konstytucyjną (następcą Stanisława Augusta Poniatowskiego miał zostać Fryderyk August Wettyn); wprowadzono równość szlachty i mieszczaństwa, jednocześnie zapewniając ochronę chłopów przez państwo; religia katolicka stała się religią państwową, jednocześnie gwarantując powszechną tolerancję religijną i wolność wyznania.

Konstytucja obowiązywała przez rok, zanim została obalona przez konfederację targowicką popieraną przez Rosję, w wyniku przegranej wojny polsko-rosyjskiej.

Świeto Konstytucji 3 maja obchodzono do ostatniego rozbioru (zostało zakazane we wszystkich zaborach). Obchody wznowiono po odzyskaniu przez Polskę niepodległości po I wojnie światowej. Ponownie zdelegalizowane w czasie II wojny światowej i po jej zakończeniu w 1945 r.

Obchody 3-majowe przywrócono w 1981 r., a od 1989 r. Święto Konstytucji 3 maja znów jest świętem narodowym. Od 2007 r. obchodzone jest również na Litwie.

## **MAJOWE ROCZNICE**

2 maja 1921 r. – wybuchło III powstanie śląskie trwające od 2/3 maja do 5 lipca 1921 r. Było to ostatnie z trzech powstań śląskich (I powstanie śląskie - od 16 sierpnia do 24 sierpnia 1919 r.; II powstanie śląskie – od 19/20 sierpnia do 25 sierpnia 1920 r.). III powstanie, pod wodzą Wojciecha Korfantego, miało na celu poprawę niekorzystnego dla Polaków wyniku Plebiscytu na Górnym Ślasku. Na mocy postanowień traktatu wersalskiego decyzję, do którego państwa należeć będzie Górny Śląsk, oddano w ręce ludności mającej się wypo-wiedzieć w 1921 r. W plebiscycie większość ludności (59,6%) opowiedziała się za Niemcami. Na życzenie Polski dodo puszczono głosowania Górnoślazaków mieszkających poza granicami Śląska, ponieważ liczono na głosy Górnoślązaków z Belgii, Zagłębia Ruhry i Zagłębia Dąbrowskiego. W konsekwencji głosy tych ludzi zaważyły na wygraniu plebiscytu przez Niemcy.

3 maja 1966 r. – na Jasnej Górze odbyły się centralne uroczystości kościelnych obchodów milenium chrztu Polski. Milenium poprzedzała Wielka Nowenna, odprawiana przez dziewięć kolejnych lat w latach 1957-1966. Inicjatorem milenium chrztu Polski był kardynał Stefan Wyszyński.

12 maja 1981 r. – po wielu miesiącach starań i strajków chłopskich został zarejestrowany Niezależny Samorządny Związek Zawodowy Rolników Indywidualnych "Solidarność". Powstał jako część ruchu "Solidarności" zapoczątkowanego w sierpniu 1980. Pierwszym przewodniczącym był Jan Kułaj. Zdelegalizowany po wprowadzeniu stanu wojennego (13 grudnia 1981 r.). Ponowna legalizacja związku nastąpiła w kwietniu 1989 r.

13 maja 1981 r. – na Placu Świętego Piotra w Rzymie turecki terrorysta Mehmet Ali Ağca dokonał nieudanego zamachu na papieża Jana Pawła II podczas audiencji generalnej na placu świętego Piotra w Rzymie. Papież spędził na rehabilitacji w szpitalu 22 dni. 27 grudnia 1983 r. Jan Paweł II odwiedził Ağcę w więzieniu i wybaczył mu winy.

31 maja 1926 r. – w następstwie przewrotu majowego i złożenia urzędu przez prezydenta Wojciechowskiego, w Polsce odbyły się wybory prezydenckie. O stanowisko głowy państwa ubiegali się przed Zgromadzeniem Narodowym: Józef Piłsudski i Adolf Bniński. Posiedzeniu przewodniczył marszałek Sejmu Maciej Rataj. W głosowaniu Zgromadzenia Narodowego zwyciężył Józef Piłsudski, który odmówił objęcia stanowiska, poparł natomiast kandydaturę naukowca – profesora chemii Ignacego Mościckiego.

#### **URODZILI SIĘ / ZMARLI**

20 maja 1881 – urodził się Władysław Sikorski, wojskowy i polityk, generał broni Wojska Polskiego, premier i minister spraw wojskowych II Rzeczypospolitej, Naczelny Wódz Polskich Sił Zbrojnych i premier Rządu RP na Uchodźstwie podczas II wojny światowej. Zginął w katastrofie lotniczej w Gibraltarze 4 lipca 1943 r. podczas powrotu z inspekcji sił Armii Polskiej na Bliskim Wschodzie.

21 maja 1841 – zmarł Julian Ursyn Niemcewicz (ur. 16 lutego 1758 r.) polski dramaturg, powieściopisarz, poeta, historyk, pamiętnikarz, publicysta, tłumacz, zastępca wielkiego mówcy Wielkiej Loży Narodowej Wielkiego Wschodu Polskiego w 1781 roku, członek Komisji Edukacji Narodowej w latach 1791-1792.

21 maja 1851 – urodził się Stanisław Witkiewicz, polski malarz, architekt, pisarz i teoretyk sztuki oraz twórca i popularyzator stylu zakopiańskiego; ojciec Stanisława Ignacego. Zmarł 5 września 1915 r. w Lovranie (obecnie Chorwacja).

28 maja 1981 r. – zmarł prymas Polski kardynał Stefan Wyszyński (ur. 3 sierpnia 1901 r.), biskup lubelski, arcybiskup metropolita gnieźnieński i warszawski, po śmierci nazywany Prymasem Tysiąclecia.

29 maja 1861 r. – zmarł Joachim Lelewel (ur. 22 marca 1786 r.), polski historyk, bibliograf, numizmatyk, poliglota, heraldyk i działacz poli-(Wikipedia) tyczny.
