# **CANDIDATES FOR THE 2022-2026** PRCUA EXECUTIVE BOARD

The Polish Roman Catholic Union of America will hold its 63rd National Quadrennial Convention on August 12-14, 2022 at the Hilton Chicago/Oak Brook Hills Resort & Conference Center in Oak Brook, IL. One national chaplain, three national officers and fifteen national directors are to be elected at the PRCUA Convention.

Seventeen members have officially declared their candidacy for office and sixteen applications were approved by the PRCUA Candidates Qualifications Committee on June 11, 2022.

The current PRCUA national chaplain, president, vice president and secretary-treasurer will run unopposed and will automatically be elected as the national chaplain and the executive officers.

The number of submitted and approved applications for the directors of Districts 1, 2, 4, 5, 6, 8 and 9 is the same as the number of places available for election, therefore all the candidates will automatically be elected as directors. There were three applications submitted for the director positions of District 7. One application was disqualified by the PRCUA Candidates Qualifications Committee, thus the remaining two candidates will be elected as the directors of District 7. Three applications were filed for the position of director of District 10 and their eligibility was approved by the PRCUA Candidates Qualifications Committee. All three names will be listed on the ballot and an election will be held to fill the two positions available.

There were no applications submitted for the positions of the two directors of District 3. Two vacancies will be declared.







Pledging Allegiance to the Flag

After lunch, a closing prayer was read by Emilia Wiecek, followed by singing of America the Beautiful, led by Mateusz Bomba.

The celebration was organized by the PRCUA Fraternal Department. Conrad Wiecek details and his daughter Emilia coordinated the event, decorated the Social Hall and served the meal.

#### History of the Pledge of Allegiance

The first version, with a text different from the one used at present, was written in 1885 by Captain George Thatcher Balch, a Union Army officer in the Civil War. In August 1892, a socialist Baptist minister, Francis Bellamy revised Balch's verse as part of a magazine promotion surrounding the World's Columbian Exposition.

The original Pledge read: "I pledge allegiance to my Flag and the Republic for which it stands, one nation, indivisible, with liberty and justice for all." The Pledge was later adapted in 1923 to change "my flag" to "the flag of the United States of America" which would make it an American pledge rather than a universal one.

The pledge was adopted by Congress in 1942. The official name of The Pledge of Allegiance was adopted in 1945. The most recent alteration of its wording came on June 14, 1954, when the words "under God" were added.

# PMA SUMMER GALA CELEBRATES 85TH ANNIVERSARY OF OPENING AT PRCUA

Nearly 300 guests attended the 42nd Annual PMA Summer Gala, held at Café La Cave in Des Plaines, IL, on June 10. This year, the Polish Museum of America celebrated the 85th anniversary of its opening on January 12, 1937.

The black-tie affair began with cocktails and hors d'oeuvres, followed by dinner and program, which began with 2022 Summer Gala Chair Sharon Orlowski welcoming everyone to the elegant event. Micheline Jaminski, PRCUA Vice President and PMA Executive Board Vice President, was the Mistress of Ceremonies. James Robaczewski, President of the PRCUA and Chairman of the PMA Executive Board, led guests in singing of the American and Polish national anthems, after which Pastor of the Holy Trinity Polish Mission and PMA Chaplain Rev. Andrzej Totzke, SCHr said invocation.

Before dinner, PMA President Richard Owsiany and Managing Director Małgorzata Kot raised their glasses for a toast. During the delicious dinner, violinist Anthony Kawalkowski from the Anthony Kawalkowski Orchestra serenaded each table to the accompaniment of his ensemble.

After dinner, the program began with Sharon Orlowski introducing the Mistress of Ceremonies, Micheline Jaminski, who presented remarks on this special occasion. Mrs. Jaminski referred to the history of the foundation of the PMA and its 85-year long mission of preserving Polish heritage and culture.

Since 1873, the mission of the PRCUA has been to provide financial security to its members through financial products, as well as offering opportunities for cultural, educational and spiritual growth. By the 1890s, the population of Poles in America reached 800,000, with the majority in Chicago. In 1891, a Polish library and national museum in North America was established in Chicago, but was later moved to Alliance College in Cambridge Springs, Pennsylvania. After a massive fire destroyed all the museum contents at the college, Polonia was left without a site "attesting to its presence." The need for a Polish museum in the United States continued to be discussed, but it wasn't

until 1935 that PRCUA President Joseph L. Kania proposed "the establishment of a permanent Museum and Archives of Polonia at the Polish Roman Catholic Union of America," right back where it originated - Chicago. The PRCUA building underwent a series of modifications that lasted through 1936, and on January 12, 1937, the Polish Museum of America officially opened with a grand gala in the Great Hall, attended by many dignitaries including the Polish consul and the mayor of Chicago. The "Man of the Hour," President Kania, then introduced Mieczyslaw Haiman as the first curator, archivist and librarian to undertake the monumental task of getting the museum on its feet, which he did to great success.

To this very day, the PRCUA continues to house the Polish Museum of America and is a sustaining financial contributor. The PRCUA's mission is to preserve Polish heritage and culture, and one of its greatest contributions to Polonia is the Polish Museum of America, and we are proud to join in its celebration of 85 years of serving as a cornerstone of American Polonia.

After Mrs. Jaminski's remarks, PRCUA Marketing Department Director Elizabeth Sawczuk-Jurak read the letter sent by Consul Małgorzata Bąk-Guzik from the Consulate General of the Republic of Poland in Chicago, who was unable to attend the Gala.

Following these remarks, Director Małgorzata Kot invited guests to watch the film presentation of *Mieczysław Haiman, Curator of Polonia's Heritage*. The short production featured PMA employees talking about the history of the museum and the contributions of its first curator, Mieczysław Haiman.

The program continued with the introducation of the museum's major donors whose generosity and contributions help ensure that the PMA continues to serve the Polish Ameri-

can community and "preserve the past for the future." Each of the donors was presented with a red rose.

The highlight of each PMA Summer Gala is the presentation of the "Polish Spirit Award." The award is presented to an individual or an institution who embodies pride in their Polish heritage and has taken action to help the PMA promote and preserve Polish history, culture and traditions. This year, the museum was pleased to honor *Dziennik Związkowy* Polish Daily News and TV *Polvision*. Awards were presented to the recipients by Richard Owsiany, James Robaczewski and Małgorzata Kot.

Walter Kotaba, the founder and owner of TV Polonia, accepted the award on behalf of TV Polonia.

On behalf of *Dziennik Związkowy*, the award was accepted by Frank Spula, the president of the Polish National Alliance, which is the owner and publisher of the publication, the editor-in-chief Alicja Otap, and general manager Łukasz Dudka.

The distinguished recipients thanked the PMA for honoring them with the prestigious award.

The Gala program included an outstanding dance program performed by 2022 Cinderella Natalia Bafia and Prince Charming Marcel Duda, runners-up Weronika Kaczmarczyk and Jakub Niedzielski, and select candidates of the Adult Culture Group of the PRCUA. 



# **MILWAUKEE AVENUE IN CHICAGO DESIGNATED "POLISH HERITAGE CORRIDOR**"

The Polish Musuem of America hosted an event on Thursday, June 16, at which a new law designating the "Polish Heritage Corridor" was announced, and House Bill 5581, which was signed into law by Illinois Governor JB Pritzker on June 10, 2022, was presented. The designation will become official in January 2023.

House Bill 5581 provides that the 15-mile stretch of Illinois Route 21, otherwise known as Milwaukee Avenue, that begins at Sangamon Street in West Town and ends with Greenwood Road in the Village of Niles, is designated as the "Milwaukee Avenue Polish Heritage Corridor". The corridor will pass through historically Polish neighborhoods like Wicker Park, Avondale and Jefferson Park. It provides that appropriate plagues may be erected by the Department of Transportation along this route in recognition of the designation.

Guest speakers included sponsors of Bill 5581: State Senator Cris-Pacione-Zavas, Representative Delia Ramirez and State Representative Lindsey La-Pointe; Daniel Pogorzelski, a local community organizer and historian, and supporter of the initiative; Iwona Filipiak, Polish American Chamber of Commerce Board President, and Richard Owsiany, President of the Polish Museum of America.

Senator Pacione-Zayas stated that by designating the Polish Corridor, the state recognizes and empowers the unique cultural identity of the Polish community. The law strenghtens the Polish community connection in Illinois and supports the further economic development and prosperity of the Polish community in Illinois.

Representative Ramirez remarked: "Dan Pogorzelski was behind the idea of designating the Polish Corridor along Milwaukee Ave., which was the foundation to the Polish community for decades. It's important to honor and invest in the preservation of the state's communities' cultural legacy. Our city and our state are richer and fuller due to the many contributions of the Polish-American community. Establishing this corridor is an opportunity to acknowlege, reflect, and celebrate the rich cultural heritage of Polish Americans in Chicago and in the state. The recognition is important but the investment in the community is more important. As the state designation begins, the Polish community can apply for the funds from the Department of Commerce and invest in the economic development that the Polish community deserves. It will help spur economig development, tourism and preservation of the Polish Corridor."

Representative LaPointe commented that she is proud to represent the House District where the new Polish Corridor cuts through, and that the Polish community heritage shouldn't be taken for granted.

## **CONSTITUTION PARALLELS**

While planning the Polish Constitution Day Parade to be held Sunday, May 1, 2022, in Polish Village, I had the pleasure to meet Dr. Mitchell Bienia from the Polish American Congress. The parade and after party were organized in cooperation with the Ohio Division of the Polish American Congress, Polish Village Parma, Inc., the City of Parma, and Cuyahoga Arts & Culture. Mitch is definitely proud of his Polish heritage. It would take a whole page to list his accomplishments but that's not the focus of this article. The focus is the conversation I had with him and the information I obtained from

The Polish Constitution was adopted on May 3, 1791. The purpose was to create and establish a form of government called a constitutional monarchy. A constitutional monarchy limited the power of the monarch by establishing laws by which he must abide, and spreads that power to various components of the government, each with its own set of powers and rules. This form of government has a clear division of executive, legislative, and judiciary powers. Sound familiar? It should, as it was modeled after our own U.S. Constitution. Poland was the first

European country and the world's second to adopt this form of government. Some key points from the Polish Constitution I'd like to point out are that it guaranteed a wide range of civic rights. It placed peasants under the protection of law and abolished serfdom. It also allowed religious freedom.

Unfortunately, it didn't last. Poland was attacked, conquered and then occupied for the next 123 years. In 1918, at the end of World War I, President Wilson demanded that Poland be reestablished as an independent country. That lasted 21 years. Next came World War II. Germany and Russia invaded Poland in 1939, and followed another 50 years under communist Russian rule. In 1989, Poland overthrew communism. So not once, not twice, but three times the people of Poland fought for their freedom, and that constitution they created in 1791 was their beacon of hope for their independence, freedom and democracy.

With events evolving around the world as they are today, with Ukraine bordering Poland, with Poland welcoming their Ukrainian brothers with open arms, it's important to remember May 3, 1791, and celebrate the freedom and independence of Poland.

# 90<sup>™</sup> ANNIVERSARY OF THE 1932 **OLYMPIC GAMES IN LOS ANGELES**

The Polish Museum of America collection includes a photo of the Polish Committee and representatives of PRCUA St. Joseph Society #701 in Los Angeles, CA, welcoming a group of PRCUA members from Chicago, who went to Los Angeles to cheer on Polish athletes, and a commemorative plaque dedicated to the PRCUA by the Polish Olympic Committee in 1932. The plaque was given to the PRCUA as a token of gratitude for the financial support for Polish athletes and members of the committee who came to Los Angeles.

The 1932 Summer Olympics (officially the Games of the X Olympiad) were held from July 30 to August 14, 1932 in Los Angeles, CA. The Games were held during the worldwide Great Depression, thus only 37 nations were able to send their representations to compete. 117 events in 20 disciplines, comprising 14 sports, were part of the Olympic program in 1932. United States won 110 medals: 44 gold, 36 silver and 30 bronze medals.

This was the first time Polish athletes participated in the summer Olympics held in the U.S. (no athletes from Poland attended the 1904 summer games in Saint Louis).

Due to limited funds, a very selected and well-prepared team of only 20 athletes was sent to the Olympiad in Los Angeles. Poles competed in 3 disciplines: athletics, fencing and rowing. They won medals in all of them. Two gold

rowing and fencing.

PRCUA and other Polish diaspora organizations formed a Polish Olympic Committee and decided to raise funds to help cover the costs related to the participation of the Polish representation in the Olympics. PRCUA was represented by Directors Jan Grzemski, Franciszek J. Kempa and Antonina Włodarska. Thanks to the cooperation of Polish merchants, business owners and organizations in Chicago, the so-called Olympic Stamp Week began, during which Olympic-themed stamps imported from Poland were sold in 70 Polish businesses. Stamps, priced at 10 cents, were also sold at the PRCUA Home Office, and President Olejniczak appealed to all PRCUA members to support Polish team by purchasing them.

Olejniczak also encouraged PRCUA members and all Polish Americans to purchase the Polish Olympic buttons sold in the campaign organized by the Polish Union Daily (Dziennik Zjednoczenia) Sports Department. Buttons were sold for twenty five cent each.

To help the Polish Olympic team, the Executive Board also decided at one of the meetings to do-

medals were won by Janusz Kusociński in the 10,000 meter run and Stanisława Walasiewicz (Stella Walsh) in the 100 meter dash; one silver medal was won in rowing and four bronze medals went to the athletes competing in discus throw,

nate \$2,000 to the fund.

The Polish athletes were first welcomed in New York. They stopped in Chicago on the way to Los Angeles on July 17, where they were welcomed at Union Station by Consul General Dr. T. Zbyszewski, the Olympic Committee in Chicago consisting of the representatives of the Polish organizations and Chicago Polonia. The athletes were invited to a breakfast in Pearson Hotel and to the Polish Consulate.

PRCUA organized a trip to participate in the Olympic Games and tour Los Angeles. Participating were President Olejniczak with his wife Zofia, Director Ian Grzemski with his wife, Director Waleria Górska, Treasurer's assistant Jadwiga Turalska, and Home Office employee Maria Skoczylas. They were joined by President of Polish Womens' Association Emilia Napieralska; PNA Director Rozalia Petlak; Dr. Rev. Bernard Szudziński, Pastor of St. Walenty Parish in Cicero, IL; Dr. S. Napielarlski; Wojciech Soska, President of Macierz Polska and his family, and others. A whole car was reserved for the group on a train that left North Western station in Chicago on July 27. Representatives from the organizations came to the train station to send them off.

Thy arrived in Los Angeles on July 30 and were welcomed by the Polish Committee, local priest Rev. Krzemiński, members of PRCUA Society #701 and from other organizations. After they checked in the Rossly Hotel, they were escorted by PRCUA members Mr. Majewski and Mr. Pisarz to the Olympic venue where they met with the Polish athletes and then went to the opening ceremony of the Games of the X Olympiad.

On July 31, the delegation attended Polish Mass, then President Olejniczak, Director Grzemski and Rev. Szudziński visited Rev. Krzemieński before going to the stadium to watch the games and Janusz Kusociński winning his gold medal.

On July 2, the group visited the Olympic village and toured Los Angeles. In the evening, they went to the Hollywood Bowl Theater, where they watched a show of national dances and songs of the countries participating in the Olympics.

The group visited Los Angeles and the neighboring towns: Beverly Hills, Pasadena, Hollywood, San Ga-

briel, Santa Monica, Catalina Island, and others. They were warmly welcomed by local Polonia everywhere they went and were invited to several banquets and events, where President Olejniczak was one of the guest speakers. On August 8, the group left for San Francisco where they were met by a large crowd of Polish Americans in Dom Polski (Polish Home).

Polish organizations in Chicago formed a committee to welcome the Polish athletes returning from the Olympic Games on August 24, 1932. PRCUA Director Franciszek J. Kempa was elected its chairman, PNA Director Aleksander Sobota vice chairman, PRCUA Sports Comsecretary Agnieszka Kleszczyk - vice chairman; PRCUA Sports Committee member Dr. S. D. Jedlowski - secretary; PNA Sports Committee S.A. Wiśniewski - treasurer. Other PRCUA, PNA, PWofA, snf Polish Falcons executives were also actively involved in the preparations.

The breakfast was organized at Igancy Lenard's restaurant on Milwaukee Ave. Rev. Kazimierz Sztuczko, pastor of Holy Trinity Church, said a prayer and Julian Groszowski, President Olejniczak's secretary gave remarks on behalf or Mr. Olejniczak, who was unable to attend. PRCUA awarded the Polish olympians with PRCUA gold medals.

The head of the Polish Olympic team, General W. Rouppert, thanked the team for the financial support and, medals and a sincere reception.

While thinking about my column for this month, I came across a listing that details what each month of the year is dedicated to in the Catholic Church. I was happily surprised to see that the month of July is dedicated to the Most Precious Blood of Jesus. Since I was not fully aware of this, I thought it would be good to research it and share my findings and thoughts with you.

This feast day was officially added to the Roman Calendar in 1849 but was celebrated in Spain from the 16th century. It was first celebrated on the first Sunday of July to mark the liberation of Rome from the insurgents who had seized the Papal States in 1849. This feast was first placed on the calendar by Pope Pius IX and later moved to July 1st by St. Pope Pius X who wanted to reduce the number of feasts celebrated on Sundays. In 1933, to honor the 1,900th anniversary of Jesus's death, Pope Pius XI raised it to the rank of Double of the First Class, the highest rank of feast days. Later in the 20th century, after the Second Vatican Council, it was combined with the feast of Corpus Christi in 1969 but the month is still dedicated to the Precious Blood of Jesus. A priest can still offer the votive Mass to the Precious Blood of Jesus, especially on its traditional date of July 1st.

With all this history in mind, what does the feast day mean for us? What is its significance for the average Catholic? This feast finds its meaning in the Eucharist. The early Church fathers have taught that the Church was born from the pierced side of our Lord from which his blood flowed, giving us the Sacraments. Pope Clement I stated this in approximately the year 96 A.D.: "Let us fix our gaze on the Blood of Christ and realize how truly precious it is, seeing that it was poured out for our salvation and brought the grace of conversion to the whole world." For us, it is part of our Eucharistic devotion. Jesus gave us his body and blood to be our food unto eternal life. We give him thanks for this precious gift by offering him our thanksgiving, adoration, and love. We further honor him by leaving church after Mass, strengthened by the Eucharist, and going forth to bring him to a waiting world by the lives we lead, what we say and especially, what we do!

During this month of the Precious Blood of Christ, the following prayer taken from the end of the Litany to the Precious Blood might help us focus our attention and devotion to his most precious blood:

Almighty and Eternal God, Thou hast appointed Thine only-begotten Son the Redeemer of the world, and willed to be appeased by His Blood, Grant we beseech Thee, that we worthily adore this Price of our salvation, and through its power be safeguarded from the evils of this present life, so that we may rejoice in its fruits forever in Heaven. Through the same Christ Our Lord. Amen.





# PASSING OF POLONIAN ACTIVIST MARIA MIRECKA-LORYŚ

PRCUA extend the greatest sympathy to PMA historian Jan Lorys on the death of his mother, Maria Mirecka-Loryś, who passed away at the age of 106 on May 29, 2022 in Warsaw, Poland.

During World War II, in Nazi German-occupied Poland, Mrs. Mirecka-Loryś was a combatant in the underground National Military Organization. She served as Commander-in-Chief of the Women's National Military Union in the Rzeszów region.

After the war, she was persecuted by the communists who seized power in Poland. In August 1945, she was arrested by the Department of Security. She was released under the amnesty, but it was known that she would be arrested soon. Maria left Poland using false papers, and via the Czech Republic and Germany, she reached General W. Anders' II Corps camp near Ancona,

Italy, where she met her future husband Lt. Henryk Loryś. In 1946, they moved to England and in 1952, the family emigrated to the United States.

Maria was active in a number of Polish organizations. She participated in and lead numerous political and charitable activities and organized many initiatives to help Poles in the East. She was the editor of Głos Polek, the official publication of the Polish Women's Alliance for 32 years.

Mrs. Mirecka-Loryś was a stalwart leader of Polonia organizations from her arrival in Chicago in the 1950s through her relocation to Poland in the early 2000s. She was an ardent supporter and a Life Member of the Polish Museum of America.

Mrs. Mirecka-Loryś was the recipient of numerous prestigious awards bestowed on her by the Polish Government. She was awarded The Commander's Cross of the Order of Polonia Restituta (Krzyż Komandorski Orderu Odrodzenia Polski) by President Lech Kaczyński in 2006, and in 2016 President Andrzej Duda awarded her the Star of the Order of Polonia Restituta (Gwiazda Orderu Odrodzenia Polski).

Mrs. Mirecka-Loryś is survived by her son Jan, daughter Ewa and nephew Tadeusz "Ted" Mirecki.

May God grant her eternal rest and peace. Please remembr Mrs. Mirecka-Lorys and her family in your prayers.

## **POLISH NEWS BYTES**

US Army supply depot to be built in Poland - Poland plans to build a military supply depot for U.S. troops stationed in the country, Polish Defense Minister Mariusz Błaszczak announced recently. The facility will go up near Poland's Powidz Air Base some 50 miles east of Poznań. "We are building a military equipment storage facility for a U.S. Army brigade combat team," Błaszczak explained. In the event of an emergency, extra troops can be quickly flown into Poland but the military equipment they need will be ready and waiting on the spot, shortening the time needed to make them combat ready. Currently, 12,000 U.S.

troops are stationed in Poland.

Over 3.8 million have crossed into Poland from Ukraine - On one recent day, around 25,200 refugees from Ukraine arrived in Poland, compared with 22,900 a day earlier, according to the Polish border guard. Around 30,000 people also crossed from Poland to Ukraine. The total number of refugees entering Poland had exceeded 3.8 million. The daily incoming and outgoing figures fluctuate from day to day, but often the number of people returning to Ukraine is greater than those leaving it. The returning refugees are eager to reunite with their families and to start rebuilding their cities, homes and lives even though Russia's aggression continues.

# **UBEZPIECZENIA BEZ TAJEMNIC**

Robert Sobczak Specjalista ds. ubezpieczeń

Kilka faktów, o których powinniśmy pamiętać wchodząc w Medicare.

Wiele osób zbliżających się do 65 roku życia staje przed faktem zmiany planu ubezpieczeniowego na zdrowie. Wielu z nich słyszało coś o Medicare, ale tak naprawdę nie jest pewnym co i kiedy należy zrobić, by płynnie wejść w ten program federalny. Jakie przysługują nam opcje? Gdzie należy dopełnić formalności? Poniżej postaramy się usystematyzować kilka faktów, które pomogą Państwu w podjęciu powyższych decyzji.

Trochę danych statystycznych. W chwili obecnej około 12 tysięcy osób dziennie wchodzi w Medicare. Nie czujcie się więc Państwo osamotnieni w swoich wątpliwościach. Mimo, że większość z nas, ze względu na emigrację nie ma doświadczenia w porządkowaniu formalności dotyczących Medicare i emerytury to nie tylko emigranci czują się zagubieni. Przeciętny Amerykanin ma bardzo podobne rozterki, bo formalności jest sporo.

Kilka faktów, które może ułatwić Państwu życie zbliżając się do 65-tych urodzin:

1. Pamiętajmy, żeby zapisać się na Medicare na czas. Większość z nas będzie chciała dokonać tego samodzielnie w biurze Social Security Administration lub wypełniając podanie na www.socialsecurity.gov/medicareonly. Niestety w obecnej sytuacji, gdy biura Social Security Administration sa nadal zamkniete dla petentów chcących zapisać się na Medicare, pozostaje nam tylko możliwość wypełnienia podania elektronicznie przez internet lub przez telefon. Nasze biuro służy bezpłatną pomocą w wypełnieniu podania elektronicznie i pomaga w dopełnieniu wszystkich formalności z nim związanych. Umówcie się Państwo na bezpłatną konsultację już dziś dzwoniąc pod numer 844-654-5185. Pamiętajmy również, że tylko osoby otrzymujące świadczenia Social Security przed 65 rokiem życia mogą zostać zapisane automatycznie. Niestety nadal należy być czujnym i sprawdzać formalności. Pamiętajmy zasade główną. Podanie o Medicare najlepiej złożyć na parę miesięcy przed 65-tymi urodzinami. W większości sytuacji poprawnie złożone Medicare wystartuje pierwszego dnia miesiąca, w którym obchodzimy urodziny. Wyjątkiem są osoby, które obchodzą urodziny 1-go dnia miesiąca. One rozpoczną świadczenia Medicare miesiąc wcześniej.

- 2. Medicare nie jest świadczeniem darmowym. Medicare pokrywa bardzo dużo świadczeń. Jego oryginalne części - A i B mogą mieć stawki miesięczne. Dla osób z legalnym statusem, wypracowanymi i rozliczonymi 40-oma kwartałami pracy część A będzie zazwyczaj bezpłatna. Standardowa stawka za część B w 2022 roku wynosi \$170.10 i może być wyższa ze względu na czas zapisu lub poziom
- 3. Nauczmy się alfabetu Medicare A, B, C, D. Część A - pokrywa częściowo koszty szpi-

- Część B pokrywa częściowo koszty medyczne i lekarskie;
- Część C zwana często jako plany typu Medicare Advantage, jest innym sposobem otrzymania benefitów Medicare świadczonym przez prywatne firmy ubezpieczeniowe;
- Część D plany zniżkowe na leki na receptę Prescription Drug Plans.
- 4. Medicare przysługuje również niektórym osobom poniżej 65-tego roku życia będacym na rencie inwalidzkiej - disability lub będącym w końcowym stadium choroby nerek.
- 5. Świadczenia oryginalnego Medicare różnią się od świadczeń w planach typu Medicare Advantage - MA. Pamiętajmy, że plany typu MA muszą oferować co najmniej te benefity, które oferowane są przez oryginalne Medicare, ale często oferują także dodatkowe świadczenia nie pokrywane przez oryginalne Medicare.
- 6. Oferty planów typu Medicare Advantage uzależniona jest od miejsca zamieszkania beneficjenta Medicare. Zazwyczaj każdy powiat będzie posiadał inną ofertę.
- 7. Oryginalne Medicare nie ma networku. Należy tylko upewnić się, czy dana placówka lub lekarz akceptuje Medicare.
- 8. Oryginalne Medicare nie pokrywa usług dentystycznych, okulistycznych i badań słuchu oraz Long Term Care. Niektóre z tych świadczeń mogą być pokrywane przez plany typu Medicare

Gen. Józef Chłopicki (1771-1854), jako młody oficer walczył w obronie Konstytucji 3 Majowej, w powstaniu kościszkowskim, w Legionach,

w Hiszpanii i w centralnej Europie. Za udział w walkach w 1812 roku został uhonorowany i jego nazwisko wykute jest na Łuku Triumfalnym "Arc de Triomphe" w Paryżu. Chłopicki walczył również w powstaniu listopadowym jako dowódca i zwykły żołnierz. Przesyłka z darami (w wyniku decyzji członków rodziny po likwidacji domu dziadków) dotarła do MPA jeszcze w marcu 2022 r. Darowi towarzyszy drzewo genealogiczne rozpoczęte w 1414 r., które wskazuje na pokrewieństwo. Informajce o darze i koneksjach rodzinnych pochodzą z korespondencji Roberta Fischera z historykiem MPA Janem Lorysiem, który był inicjatorem uroczystości.
