PRCUA Declares a Net Gain in the First Quarter

Message from the President

Dear Members:

The Polish Roman Catholic Union of America hereby declares a net gain from operations of \$330,525 for the first quarter of 2010. This is the first quarterly gain in this area since March 31, 2005. Reduction in expenses over the last 12 months resulted in a positive change of \$640,318 from the first quarter of 2009. At that time, we experienced a loss of (\$309,793).

After adjusting for refunds to members and net realized losses of (\$7,263), the net income was \$288,871.

Another positive effect on the organization includes an increase of assets to \$182,368,053, compared to \$178,199,480 in December 31, 2009. This is a continued positive growth in assets of \$4,168,573.

There was also positive growth in premium income from the March 31, 2009 figure of \$3,607,714 to the March 31, 2010 figure of \$4,888,234. This \$1,280,520 increase is a reflection of the positive nature of our membership in the PRCUA. The members' positive attitude will result in a continued growth in their organization.

Net investment income has increased from \$2,157,604 to \$2,233,883 as of March 31, 2010.

Contributing to this positive gain in operations was a reduction in expenses in most areas of our organization: a reduction of salaries of officers, reduction in staff, and cost savings in our official publication, Naród Polski, from bi-monthly to monthly – only to mention a few changes.

The PRCUA administration continues to anticipate continued positive growth in both net income from operations and our assets during this year.

The 2010 Growth Record Report recently produced by Standard Analytical Service, Inc. compares PRCUA's growth as of December 31, 2009 with the growth of an average of the 25 largest life insurance companies. When comparing the below listed categories, positive changes can be observed.

PRCUA members can simply present the free HealthTrans® Access Discount Drug Card along with a valid prescription, at more than 58,000 participating pharmacies nationwide, and you could save 10% to 85% on the prescription drug cost.

There is no limit as to who may benefit from this PRCUA Fraternal Program. The PRCUA will benefit by receiving a donation from HealthTrans® Access of \$0.50 for every new prescription filled.

This prescription drug program is in addition to the ScriptSave program, which has been available for free to PRCUA members for several years. The difference is that in each program the cost of prescription drugs and/or the pharmacies where the card can be used may vary. PRCUA members may sign up for one card or the other program, or both. There is no fee and the discount is taken on the cost <u>after</u> your health insurance payment for prescription drugs.

Member Asks a Question about Annuities

Question: I am currently an annuity owner and want to know if my money is guaranteed in the event your organization fails. I need to know, before I invest any more money, that it is protected in some way.

RESPONSE: Thank you for your membership and your annuity deposits. Please be assured that your money is secure. Economic factors regarding insurability of funds are handled in three main ways:

- **1. BANKS** According to the Federal Deposit Insurance Corporation (FDIC) government website, "FDIC preserves and promotes public confidence in the U.S. financial system by insuring deposits in banks and thrift institutions for up to \$250,000 (through December 31, 2013); by identifying, monitoring and addressing risks to the deposit insurance funds; and by limiting the effect on the economy and the financial system when a bank or thrift institution fails." This benefit is available because existing banks pay into an insurance fund for insolvency. If additional funds are needed, Washington, DC will need to rely on taxpayer funds. In essence, the banks rescue one another.
- **2. COMMERCIAL LIFE INSURANCE COMPANIES** (mutual or stock) rely on support from the state guarantee fund through state guaranty associations which provide coverage in the event of insolvency **but this fund has limits as well**. The fund is supported by a tax placed on the life insurance company's premium income. This is the system that is in place to rescue commercial life insurance companies. On occasion, taxpayer funds may be used as well.
- **3. FRATERNALS** As a fraternal organization, PRCUA insures itself, without support from taxpayers or premium taxes payable to the state. In the unlikely event that PRCUA were to become insolvent and need funds which were not available, PRCUA members would be assessed. As a fraternal organization, members rescue each other, without relying on government assistance as banks and commercial life insurance companies do. If this is not possible, the PRCUA would merge with another fraternal, if rescue were required.

The latter is a highly unlikely occurrence as the PRCUA is very solvent. Currently, PRCUA is meeting all death claims and cash surrenders. We are also crediting monthly interest to our annuity account holders. The adjustment in Annual Percentage Yields (APY) offered on annuities reflects only the return on investments that is available to the PRCUA.

Since 1997, three fraternals have merged with our organization - two within the last five years. One of these fraternals was insolvent, while the other was on the verge of becoming insolvent

PRCUA's domicile is Illinois. A recently completed state audit of our organization has found no major deficiencies. The recent state examination report is shared with all insurance departments in states in which the PRCUA does business.

Standard Analytical Service, Inc. has identified and analyzed our growth pattern as compared to the average 25 largest life insurance companies. Our growth percentage is comparatively higher than the average 25 largest life insurance companies.

One cannot rely strictly on ratings by rating agencies. For example, recently we learned that an Indiana commercial life insurance company, rated in the A category for many years, has had a Rehabilitation Petition filed against it by the Department of Insurance Commissioner of the State of Indiana.

Economic problems have developed across the United States. Very recently, Harrisburg, the capital of Pennsylvania, has missed a bond payment for the second time (WSJ, April 30, 2010). Luckily, the bonds were insured by an insurance company which covered the payment on bonds. The PRCUA does not claim any ownership to these bonds.

Average CD Yields Continue to Drop - Alternative Available!

In the Money Section of the Friday, May 21, 2010 issue of *USA Today*, the latest CD yields snapshot is not encouraging for many of us who are savers. According to *USA Today*, the average certificate of deposit yields as of Wednesday, May 19th are as follows:

- 6-month average for the past two weeks was 0.42%, as compared to 0.96% a year ago.
- 1-year average for the past two weeks was 0.70%, as compared to 1.23% a year ago.
- 2 ½-year average for the past two weeks was 1.10%, as compared to 1.37% a year ago.
- 5-year average for the past two weeks was 2.12%, as compared to 2.22% a year ago.

There appears to be a downward trend in interest rates that continues to affect attempts at saving.

A more attractive alternative is available, especially if you are age 59 ½ or older. The Polish Roman Catholic Union of America is currently offering the following annuities:

Bishop Paprocki Chosen to Head the Diocese of Springfield, IL

Pope Benedict XVI has appointed PRCUA member Auxiliary Bishop Thomas J. Paprocki of the Archdiocese of Chicago to be the new bishop of the Catholic Diocese of Springfield, IL.

The appointment was announced on April 20 in Washington, D.C., by Archbishop Pietro Sambi, Apostolic Nuncio to the USA. "We are grateful to God, to His Holiness Pope Benedict XVI and to Francis Cardinal George for choosing such a gifted and dedicated priest and bishop to serve us," said

Msgr. Carl Kemme, Diocesan Administrator, who introduced Bishop-designate Paprocki to the community during a news conference later that morning at the Cathedral of the Immaculate Conception in Springfield.

"I am deeply grateful for the confidence shown by our Holy Father, Pope Benedict XVI, in appointing me to serve as the 9th Bishop of Springfield in Illinois," Bishop Paprocki said. "...I pledge to do my best with the help of God's grace to build on the fundamental blessings established through the dedicated ministry of the previous bishops of Springfield, especially my immediate predecessor, the Most Reverend George Lucas, now Archbishop of Omaha."

A farewell Mass was held in honor of Bishop Paprocki at St. Constance Parish in Chicago on Monday, May 17th, concelebrated by His Excellency Bishop Paprocki, Rev. Michal Osuch pastor of St. Hyacinth Basilica and Rev. Tadeusz Dzieszko, pastor of St. Constance Parish. PRCUA President Wallace and First Lady Joann Ozog and Mark and Resident Vice President Anna Sokolowski were present, as were many members of Polonia to express their gratitude to the Bishop for his many years of service to Chicago Polonia and the Church.

Bishop Paprocki, a native of Chicago, was born Aug. 5, 1952. He was ordained to the priesthood on May 10, 1978 in Chicago. He is a canon lawyer, with a doctoral degree from the Pontifical Gregorian University in Rome (1991), and is also a graduate of DePaul University College of Law in Chicago (1981).

In addition to his parish assignments, he served the Archdiocese of Chicago as Vice-Chancellor (1985-2000) and Chancellor (1992-2000). He was ordained Auxiliary Bishop for the Chicago Archdiocese on March 19, 2003. He serves Chicago Cardinal Francis George as Vicar for Vicariate IV; the cardinal's liaison to Polonia and for Health and Hospital Affairs.


An installation Mass will be held Tuesday, June 22, at the Cathedral of the Immaculate Conception in Springfield. The Diocese of Springfield comprises approximately 146,000 Catholics in 131 parishes in Central Illinois.

Archbishop-Designate Thomas Wenski to Head Miami Diocese

Bishop Thomas G. Wenski, 59, a member of PRCUA Society #1492, will leave the Orlando Diocese to become Archbishop of the Miami Archdiocese, with its 700,000 Catholics, effective June 1st. He will succeed Archbishop John C. Favalora.

The son of a first-generation Polish immigrant and his second-generation Polish wife, Thomas Wenski was born in Florida and ordained a priest of the Archdiocese of Miami on May 15, 1976. He earned a B.A. in Philosophy, M.A. of Divinity and an M.A. in Sociology. He took summer courses at the Catholic University of Lublin, Poland and is fluent in English, Polish, Spanish and Creole, which he learned while ministering in Haiti. In 1979, he was assigned to the newly established Haitian Apostolate of the Archdiocese. He was Associate Director and

then Director of the Pierre Toussaint Haitian Catholic Center in Miami, which provides services to Haitian immigrants. At the same time, he also served as pastor of 3 Haitian missions. Bishop Wenski has always been a tireless advocate on behalf of the Haitians. He also directed the Archdiocese of Miami Ministry to Non-Hispanic Ethnic Groups.

In 1996, Fr. Wenski was appointed Director of Catholic Charities. He was ordained Auxiliary Bishop on Sept. 3, 1997. He served on numerous boards including Catholic Hospice, Catholic Charities, Catholic Charities Legal Services, and chair of the US Catholic Conference of Bishops' Committee on Migration (2001-2004); and chair of its Committee on International Policy (2004-2008). Now he is a member of the Conference's Secretariat for the Church in Latin America and the Committee for International Justice and Peace. His committee work has taken him to the Congo in Africa, the Caribbean, Central and South America, Israel and the West Bank in the Middle East.

In 2004, Bishop Wenski succeeded Bishop Norbert M. Dorsey as the 4th bishop of the Diocese of Orlando. PRCUA Director Richard Turkiewicz of District 4 from that area of Florida said, "We of Polish descent will remember Bishop Wenski as a friend of Polonia. He felt at ease breaking bread with us in Polish restaurants, riding his Harley, blessing food at Swieconkas and offering Mass in Polish for us. We are very proud of our Bishop who tirelessly advocates comprehensive immigration reform and joined religious leaders from other faiths to argue for help for immigrants as a moral imperative. Bishop Wenski tirelessly writes articles to promote Catholic teachings and social messages. His articles in the opinion column of the *Orlando Sentinel* will be missed."

The PRCUA extends best wishes to PRCUA member Bishop Wenski and we ask all members to please keep this inspiring Church leader in your prayers.

LAZY PIEROGI

Lillian R. Dattilo, Arlington Hts., IL

1/2 pkg Kluski noodles

2 cans mushrooms, drained

2 lb. sauerkraut, drained

2 cans mushroom soup, undiluted

Cook and drain kluski according to pkg. Lightly fry onions. Mix all ingredients together and put into greased 9 x 13 pan. Bake at 350 degrees for 30 minutes.

NOTE: You can put slices of Polish sausage on top of the casserole for added flavor.

CHRUSCIKI

Add 1/2 tsp. salt to 5 egg yolks; beat till light and lemon colored. Gradually add 3 tbsp. sugar, 1 tbsp. brandy and continue to beat well. Sift 2-1/2 cups flour, add alternately with 5 tbsp. sour cream, beating after each addition. Knead dough until soft & shiny. Wrap in plastic wrap, refrigerate 1/2 hour. Roll thin and shape chrusciki. Fry in Crisco oil, drain on paper; sprinkle with powdered sugar. I use a Kitchen Aid mixer!

BELGIAN BUSTER BAR DESSERT

1 (15 oz.) pkg. Oreo cookies
1 gallon ice cream - softened
1 small jar caramel topping
1 cup butter
2/3 cups chocolate chips
1 stick margarine, melted
1-1/2 cups Spanish peanuts
2 cups brown sugar
1-1/2 cups evaporated milk
Cool Whip

Crush cookies, mix together with melted margarine. Press into bottom of 9" x 13" pan. Spread ice cream over crust; cover with peanuts and caramel topping. Freeze. In saucepan, combine brown sugar, butter, evaporated milk and chocolate chips; boil for 8 minutes. Cool. Frost ice cream with chocolate; cover and return to freezer until ready to serve. Serves 15-18. Take out of freezer 10 minutes before serving. Garnish with Cool Whip.



There are new guidelines which will permit individuals who qualify to receive a rebate between \$250.00 and \$650.00 from property taxes or rent paid during 2009. Funding for this rebate program is made possible from the Pennsylvania State Lottery Fund.

Applicants should note that no lien or judgement is placed against their property nor will this rebate ever have to be repaid. To qualify, you must be a senior citizen 65 years of age or older, a widow or widower 50 years of age or older or a disabled person 18 years or older.

Homeowners who have annual incomes of \$35,000 or less and renters with annual incomes of \$15,000 or less could qualify. <u>Only half of your annual Social Security or SSI income is counted toward the income guideline.</u>







School in Buffalo, New York. After graduation, she will enter the Academy for *Plebe Summer* on July 1, 2010.



Joann (nee Kushel) Ozog was born in Detroit, MI and moved to Illinois in 1998 when her husband became National President of the PRCUA. Since she was not one to sit home, Joann decided to volunteer her time at the Polish Museum of America (PMA).

With her background in education, Joann realized that the Polish Museum needed to offer programs, events and activities that not only would reach the Chicagoland Polish community but also the many diverse nationalities in Illinois.

For the young and old alike, Joann introduced a variety of hands-on workshops: Christmas ornaments, Palm Weaving, Egg Painting, Pisanki, Wycinanki, Genealogy as well as Pierogi and Golabki Demonstrations. She introduced the Polish American Heritage Month and Polish Constitution Day art contests for students K-12. She also instituted a successful Polish American Heritage Program and Dinner during October and Wigilia Programs and Dinners for adults, children and tour groups at Christmas. Throughout the year, she ran workshop/tour/luncheon programs for all ages and nationalities. She invited groups of children and adults to decorate Christmas trees in the Museum. She also wrote six activity workbooks for students and adults (two on the Polish Museum, two on Casimir Pulaski, one on Polish Settlers in Chicago and one on Ignacy Paderewski).

To make the PMA a more vibrant institution, Joann and her Committees re-introduced the membership campaign and the Quarterly PMA Newsletter. She raised money to renovate the Library, the Great Hall and the Archives, turned a storage room into a conference room for museum personnel and found areas for the Museum's photo and music collection. To save the PMA's precious treasures, Joann introduced the "Save the Book", "Adopt a Book" and the "Photo Restoration" projects.

When personnel came to Joann and said "I wish we had this or I wish we had that, she initiated a "Wish List" whereby money was donated by generous donors to purchase computers, printers, fax machine, furniture, television, camera, CD/DVD player, vacuum cleaners and many needed items.

In conjunction with membership, Joann introduced the "Benefit Event," which not only was a fundraiser but it also honored 113 Life Members, each of whom donated \$2,500 to the Museum. She also started a "Volunteer Appreciation Luncheon" to recognize and honor the many individuals who donate their time and talents to the PMA all year long.

During the period when Joann gave her time to the Museum, over one million dollars was brought into the Museum, with the help of many volunteers.

In April of 2008, Joann was asked to turn her energy towards the PRCUA Education Fund, Inc. to raise money for scholarships for our young members, who are trying to get a higher education. Since that time to the present, her fundraising efforts have raised over \$55,000 for this scholarship program.

Joann loves what she does. During the past twelve years that she has lived in the Chicago area, she has met many generous and caring people from multiple nationalities. She is very proud of her Polish heritage and is pleased to have been able to promote the beautiful Polish customs and traditions among so many wonderful people in Chicago.

PRCUA Members are Honorary Chairs of Papal Exhibit

Buffalo, NY – Cansius College and The Permanent Chair of Polish Culture, with the support of the Catholic, Jewish and Polish communities of Western New York, is hosting the exhibit "A Blessing to One Another: Pope John Paul II and the Jewish People." The exhibit opened on April 16 at the Karpeles Manuscript Library Museum in Buffalo, NY and will be on display through June 30, 2010.

"A Blessing to One Another" is a commemorative tribute to the late pontiff, his extraordinary life and his legacy of improved dialogue between Catholics and Jews. It chronicles the pope's associations with the Jewish community from the time of his childhood through to his papacy, and illustrates how these lifelong associations shaped his papacy, the Catholic Church and the future of Jewish-Catholic relations.

Pope John Paul II broke the chain of years of painful history between Catholics and Jews. He was the first pope to enter a synagogue in 2,000 years, as well as the first pope to establish diplomatic relations with and officially visit the State of Israel. Pope John Paul II also spoke of repentance for past treatment of the Jewish people.

National Director of District 2, William Nowakowski and his wife, Dr. Mary Turkiewicz, attended the Opening Reception, along with other dignitaries. Honorary chairs of the event are Rev. Vincent M. Cooke, S.J., President of Cansius College; Edward U. Kmiec, Bishop of Buffalo; Donald and Edie Day; Mary Lou Turkiewicz, MD; and William Nowakowski, Esq.

The Nowakowskis were given a personal tour of the Exhibit by one of its creators Rabbi Abie I. Ingber of Xavier University. The Rabbi's parents were from Eastern Poland, where they lived during the war. The three Xavier University men who created this Exhibit met with Pope John Paul II on several occasions to discuss the project. They feared that part of the Exhibit would not be complete because they had requested a few personal items from the Pope but the Vatican did not respond before the Pope died. However, Pope John Paul II did make his wishes known as to what items he wanted to donate to the exhibit and they are now part of it.

Mary told the Rabbi the story of how her grandfather, Michael Skrzypczyk, met Cardinal Karol Wojtyla, before he became Pope, in Buffalo, NY. The Cardinal stayed at St. Casimir's Rectory during his time in Buffalo. Michael met the Cardinal when he was walking in the neighborhood and stopped to speak to him. Since both men were from Wadowice, they ended up taking a long stroll together, discussing their home town and people whom they knew there. The Cardinal said he was hungry and they went to a pizza parlor on Clinton Street, where the Cardinal ordered pizza and they shared it. It amazed the people in the area that a Cardinal would order and eat at a simple store-front pizza parlor.

The Exhibit first opened on July 15, 2005 at Xavier University in Cincinnati, Ohio. Then it moved to the Pope John Paul II Cultural Center in Washington, D.C., where it was on display until 2006. From there it went to Duquesne University in Pittsburgh and then to New York City's Museum of Jewish Heritage and the Holocaust Museum of Houston, TX.

More than a mere historical exhibit, "A Blessing to One Another" is an interactive experience that allows visitors to follow in John Paul II's footsteps from his childhood to his role as head of the world's largest church. The exhibit is divided into four major sections, reflecting the four periods in his life. Visitors become part of the documentary, walking through a multi-sensory experience: backdrops of enlarged photos and period postcards supporting artifacts, all set against evocative soundscapes.

The first section centers on Wadowice, Poland, where Karol Wojtyla grew up in an apartment owned by a Jewish family and established friendships with Jewish children, including lifelong friend Jerzy Kluger. Visitors view Wojtyla's baptismal certificate and school records, and see the world as it looked from his bedroom window.

The second section centers on Krakow and enters the dark years of World War II through a replica of the Krakow Ghetto gate. During the Nazi occupation, the future pope was forced to take his university studies underground, while working in a factory by day. Displayed in this area are somber reminders of the Holocaust, including prayer shawls and shoes from the Holocaust Museum at Auschwitz.

The third section traces Wojtyla's rise from priest to bishop to cardinal. During this period he participated in the Second Vatican Council's dramatic change in the Church's relationship with other religions. As bishop of Krakow, he also established close ties with the Jewish community. Among the artifacts in this section, visitors find the biretta worn by Wojtyla when he became a cardinal and handwritten notes for one of his books.

The final section celebrates John Paul II's papacy. It features a ceremonial lamp and papal vestments from the 2002 World Day of Prayer at Assisi, videos of religious and world leaders speaking with the pope, and a replica of Jerusalem's Western Wall.

Interview with Teddy Sliwinski

Chairman of the Slavic Village Polish Constitution Day Observance, which was held in Cleveland, OH on May 2, 2010 was Teddy Sliwinski. He was interviewed by Ewa Trzeciak, an employee of the PRCUA

Ewa: You are passionate about Polish matters, how did this happen?

Teddy: I was born in Slavio Village; both parents came from Ciechanow, Poland and I spoke Polish only until I started school. In my early teens, l worked for a Polish travel/ import agency and in the kitchen of the Alliance of Poles now PRCUA. In 1978, seeing the decay in the commercial area of the neighborhood, I created the local development corporation, obtained city and federal funds and began "Slavio /illage". It was not only fun but also rewarding to help revitalize the Polish neighborhood. But today it is much different.

What is the future for the village? We are rather lucky The plague of foreclosure and fraud allowed about 30% of the village to be demolished. It turned out to be a good thing as all the bad properties are disappearing, with green areas and lots that will eventually be filled with new housing. We are surrounded by bike trails, the only waterfall in the city and the only golf course in the city Virtually, all the Polish organizations and churches are located here. The future here will be very bright.

What about your professional background? I attended Cleveland State University with a degree in Political Science and Speech. I then completed law school at Cleveland John Marshall earning my juris doctorate and was living in Ohio since 1975. I am a graduate of the USMC/PLC program at Quantico, VA. I am also licensed in the State of Florida. For over 20 years, I was the Ohio legal (Cont. on page 13)

Healing the Katyn Wound?

Warsaw - Never was there more hope that an issue poisoning Polish-Russian relations since the early 1940s might finally be resolved within the foreseeable future. The Kremlin has never been so open about Stalin's 1940 Katyn Massacre of 22,000 Polish officers or so willing to share hitherto secret documents with Poland. This change of heart did not come about as a spontaneous awakening, however. It was forced on Moscow by the politically awkward and embarrassing tragic demise of Poland's top political and military elites in a Soviet-built plane on Russian soil while en route to a Katyn commemoration. The Katyn controversy, which Russia had held under wraps, suddenly got publicized ny the international media like never before.

Russia's top leadership suddenly decided to launch what observers have described as a "charm offensive". The Smolensk tragedy unleashed in Russia both a grass-roots and official outpouring of sympathy and solidarity with the Polish people. Whereas Iceland's volcanic-ash cloud scared most world leaders away from the state funeral of President and Mrs. Lech Kaczynski, Russian President Dmitry Medvedev felt it was his duty to attend. He also kept reiterating that it was Stalin and his comrades who bore responsibility for the Katyn crime.

More importantly, he put his money where his mouth is by ordering Katyn documents to be released onto the Internet for the first time. "Let people see it. Let them know who made the decision to kill the Polish officers. It's all there in the documents. All signatures are there, all the faces are known," President Medvedev explained. Historians from both countries have had access to these documents for many years, but their online publication marked a major departure from previous practices of keeping them from the public.

Within a short space of time, millions of Russian net surfers visited the website of the Russian State Archives and could see the Katyn death warrant. This was an official note from NKVD (secret police) Chief Lavrenty Beria suggesting the liquidation of the "incorrigibly reactionary and anti-Soviet" Polish officers captured by the Red Army. Stalin and his top henchmen affixed their signatures to it, giving the NKVD the official go-ahead to conduct the brutal murders. Everyone can now view that document at: www.rusarchives.ru/publication/katyn/01.shtml.

Although the above and six other key Katyn-linked documents had been known in Poland since 1992, when then Russian President Boris Yeltsin handed them over to his (Continued on page 14)

2010 PAPA Convention Re-elects Rev. W. Ptak & Rev. E. Orzech as National Officers

From previous articles, I hope all of our readers are already familiar with PAPA, which stands for the Polish American Priests' Association, a national organization of priests of Polish descent or serving the Polish community throughout the United States. There are over 2,300 priests in the U.S.A. who fit this description. Annually, about a hundred or so delegates gather at our National Convention. This year, it was hosted in the Archdiocese of Detroit by the Orchard Lake Schools (OLS) to allow us to help them celebrate the 125th anniversary of their founding and their 100th anniversary at their present location: the beautiful shores of Orchard Lake, MI.

On Monday, April 12th, the the delegates registered and the Officers and Board of Directors held an afternoon meeting. The first event on the agenda was evening prayer at the Shrine Chapel, led by Bishop Paul Bootkoski of Metuchen, NJ. Following dinner, Fr. Eric Orzech, National PAPA President, formally opened the Convention and a warm welcome was extended to all by our host, Fr. Timothy Whalen, Chancellor, on behalf of Orchard Lake Schools. Bishop Emeritus John Yanta of Amarillo, Texas, gave a keynote address on the founding of our organization.

Tuesday, April 13th was the first full day of the Convention. The morning was taken up with business sessions that discussed 3 Polish Americans up for canonization as saints: Fr. Walter Ciszek, S.J., the famed missionary to Russia; Fr. Justin Figas, O.F.M., the popular "Rosary Hour" priest; and Mother Teresa Dudzik, foundress of the Franciscan Sisters if Chicago. Mass was celebrated at Our Lady of Mt. Carmel Church in Wyandotte, where Adam Cardinal Maida officiated and the PRCUA's National Chaplain Fr. Walter J. Ptak is the Pastor. A wonderful luncheon was served in the parish hall and we all serenaded Cardinal Maida, who recently celebrated his birthday. After lunch, Fr. Stanislaw Flis of OLS gave a talk on historical developments of Polish parishes, as well as the Archives of OLS and how they can be of service to us all.

Wednesday's business sessions included a presentation on liturgical art, reports from various local chapters of the past year's activities and discussion on the state of the Polish Chapel at the Basilica of the National Shrine of the Immaculate Conception in Washington, DC. As it was noted that it might be time to add mosaics of Cardinals Krol, Szoka and Maida to the existing ones, it was agreed that we would look into any restoration needs of the Chapel and Icon, consulting with the Rector of the Basilica.

A pilgrimage was then made to the grave of Orchard Lake's founder Fr. Joseph Dabrowski and then we went across the street to pray at the tomb of Venerable Solonas Casey, O.F.M., whose case for canonization is also under way. Fr. Bogdan Milosz, Pastor of Our Lady Queen of Apostles Parish in Hamtramck, MI hosted the delegates for lunch, followed by a Holy Hour in the church, offered by Msgr. Charles Kosanke, Rector of SS. Cyril & Methodius Seminary in Orchard Lake. Archbishop Allen Vigneron of Detroit offered a Requiem Mass at the Shrine Chapel for R.P. President Lech Kaczynski and all the victims of the tragic airplane crash in Smolensk. The day concluded with a fine banquet in the main dining hall at Orchard Lake, where Fr. Whalen spoke on the Orchard Lake Schools and their 125th Anniversary.

Thursday was the final full Convention day. The business meeting began with OLS reports, then elections were held for the national officers and directors. Msgr. Anthony Czarnecki gave his report as Polonia's representative to the U.S. Bishops' Conference. Discussions turned to our continued efforts at reviewing the *Pastoral Plan for Polonia* and how best to begin going about that this year. It is an important project which needs to involve Polonia's leaders and experts and must be done properly to serve us effectively for many years to come.

The remaining reports were given from PAPA's local chapters and the election results were announced: Fr. Eric Orzech of Cleveland, OH (PRCUA member) was reelected as National President; Msgr. Peter Zendzian of Brooklyn, NY was elected Vice-President; Fr. James Miara of (Bronx) New York, NY was re-elected Secretary; and Fr. Walter J. Ptak of Wyandotte, MI (PRCUA National Chaplain) was re-elected Treasurer. The Board of Directors for the next 2 years include: Canon Thomas Machalski, Brooklyn, NY; Msgr. Daniel Plocharczyk, Hartford, CT; Fr. Marek Kaminski, Syracuse, NY; Fr. Maciej Melaniuk, Metuchen, NJ; Fr. Miroslaw Krol, Newark, NJ; Canon Joseph Sredzinski, Greensburg, PA; Fr. Nicholas Coffaro, Saginaw, MI; Fr. Robert Witkowski, Detroit, MI; and Fr. Walter Rakoczy, Gary, IN.

After lunch and activities on the OLS campus, Mass was celebrated in Our Lady of Czestochowa Church in Sterling Hts., MI, staffed by the Society of Christ. Bishop Yanta was the main celebrant, joined by Bishop Thomas Paprocki of Chicago, with Fr. Eric Orzech preaching. The gala Convention Banquet was held at the American Polish Cultural Center in Troy, MI, where Msgr. Anthony Muntone of Allentown, PA spoke about famed Orchard Lake alumnus and candidate for sainthood, Fr. Walter Ciszek, S.J.

The 2010 Fr.Leopold Moczygemba Award, PAPA's highest honor, was bestowed upon Fr. Stanislaus Flis, Director of the OLS Archives.

(Continued from page 12) Polish counterpart Lech Walesa, Medvedev also turned additional Katyn-related files over to Poland and pledged that Russia would continue the declassification process with regards to the remaining files. The families of Stalin's victims are hoping those files will include the names of several thousand slain Polish officers who are still missing and unaccounted for. They are believed by many to lie buried somewhere in Belarus.



The Katyn wound has

festered since 1943, when invading Nazi troops found more than 4,400 corpses of murdered Polish officers in the Katyn Forest near Smolensk. Stalin blamed the Germans for the atrocity and, when the London-based Polish Government-in-Exile demanded an international investigation, broke off diplomatic relations with the Poles. For four and a half decades after Stalin imposed a Soviet-style puppet regime upon Poland, Poles were beaten, jailed, fired or otherwise persecuted for questioning the "Katyn Lie" ascribing the crime to the Nazis.

In his address which was to be delivered shortly at a national 70th-anniversary pilgrimage to Katyn, Pres. Kaczynski was to have said: "Concealing the truth about Katyn became a cornerstone of the PRL (Stalin's puppet state officially known as "the Polish People's Republic"). People paid a high price for remembering the truth about Katyn (...) And Katyn has become a painful wound in Polish history, poisoning relations between Poles and Russians. Let us make sure it can finally heal. We are already on that path. We, Poles, appreciate Russia's actions in recent years. We should go further along that path bringing our two nations closer."

Little could he have known that it would take a national tragedy for Moscow to revise its stand on the atrocity. Pres. Medvedev echoed Kaczynski's views, when he called Katyn "an example of the falsification of history." And added: "We, Russians, have done that. (...) If we turn a blind eye to the crimes, they may happen again in the future. These crimes have no expiry date and those who committed them should be punished, no matter how old they are." Although circumstances have forced the change in tactics upon the Kremlin, it may nonetheless help improve two-way relations. But it is naive to believe that Russia has changed its long-term strategy of restoring the prestige, pride and confidence of the big-power status it first achieved under Stalin during and after World War II.

Moscow will probably reject all attempts to equate Katyn with a political crime or genocide. The Kremlin fears that descendants of Katyn victims may demand damages before international tribunals and they could be joined by the families of millions of Ukrainians starved to death in Stalin's artificially-induced 1930s famines. And ethnic Russians themselves might stand up and demand justice, since the majority of those killed or sent to labor camps in Stalin's purges had been their relatives.

The reason the Polish Cultural Garden at Rockefeller Park has been chosen as the clean-up site for Join Hands Day is that a wreath-laying ceremony takes place there, usually on the first



Sunday of May, as part of Polish Constitution Day celebrations. The garden is usually filled with debris that accumulates during the winter months. The clean-up project is a community service for the neighborhood; it fulfills the requirements of the Join Hands Day project; and it prepares the site for a Polonia event on the next day.

Volunteers were surprised this year to find that the hardest part of the work was already done by whom, we do not know. It was a pleasure to put finishing touches on the garden. It was gratifying to stand back when the job was done, and admire the beautiful Polish Cultural Garden.

Mszą św. w kościele św. Stanisława w Milwaukee, WI, rozpoczął obrady w dniu 6 października 1933 r. 33. Sejm ZPRKA. Mszę św. celebrował J.E. bp Rohde, we koncelebrze uczestniczył również arcybiskup Sebastian G. Messmer.

Sejm obradował w Domu Polskim im. T. Kościuszki. Bezpośrednio przed otwarciem obrad, tłumnie wymaszerowano do pomnika Kościuszki w Parku Kościuszki, gdzie Zjednoczeńcy złożyli wieniec pod pomnikiem.

Marszałkiem Sejmu wybrano sędziego Ignacego F. Dankowskiego z Chicago, sekretarzami: Józefa A. Dumanowskiego i Franciszka Czaję. Obecnych było 400 posłów.

W godzinach wieczornych pierwszego dnia Sejmu Towarzystwo Śpiewu Harmonja wystawiło w sali sejmowej operetkę pt. "Zemsta nietoperza".

Najważniejszymi sprawami organizacyjnymi w czasie obrad 33. Sejmu były projekty: Osad i Gniazd Dziecięcych, założenia nowej drukarni Zjednoczenia i wydawania dziennika oraz przejęcia przez ZPRKA na własność Polskiego Domu Emigracyjnego św. Józefa w Nowym Jorku i inne.

Projekt stworzenia Osad w całej organizacji został zaaprobowany przez Sejm. Pierwsze Osady powstały samoistnie w Buffalo, NY i zostały założone już w 1908 r. przez tamtejsze towarzystwa. Ideę tą przejęły towarzystwa z Nowej Anglii, Massachusetts (gdzie nazywano je Łączność), Connecticut (pod nazwą Gmina) i Pensylwanii. Jako cele Osad Sejm określił: "obrona Zjednoczenia na polu religijnym i narodowym, szerzenie braterskiej jedności i solidarności i podtrzymanie ducha narodowego przez oświatę, wspólne obchody narodowe i dążenie do zacieśniania węzłów braterskich wśród Polaków w okolicy oraz zakładanie nowych towarzystw ZPRKA i wspieranie potrzebujących członków ZPRKA.

Zaaprobowany został też projekt Gniazd Dziecięcych - do Gniazd można było zapisywać dzieci od 9 do 13 lat za opłatą 5 centów miesięcznie. W wieku 14 lat dzieci stawały się członkami ZPRKA, a wpłacone pieniądze miały zostać w całości przelane na opłatę wstępnego i asesmentu. Opiekunami Gniazd zostały Osady.

33. Sejm uchwalił również założenie drukarni Zjednoczenia, jednak nie zaaprobowano idei wydawania własnego dziennika (która została poddana pod głosowanie).

Odrzucono również projekt przejęcia na własność Domu Emigracyjnego św. Józefa, uznano bowiem, że finansowo przedsięwzięcie to byłoby zbyt ryzykowne.

Sejm uchwalił również następujące projekty:

- zwiększenie liczby dyrektorów z Chicago z 6 do 9, z czego dwa miejsca zarezerwowano dla kobiet;
- wprowadzono prawybory dla uproszczenia procedury sejmowej;
- doradca prawny, lekarz i redaktor mieli być odtąd wybierani przez Sejmy (a nie mianowani przez zarząd);
- z funudszu żelaznego Wydziału Pomocy Naukowej przeznaczono po 1/3 na założenie drukarni i biblioteki;
- wyrażono zgodę na umieszczenie w Domu Zjednoczenia portretów ks. Wincentego Barzyńskiego, ks. Jana Radziejewskiego i ks. Teodora Gieryka - dla uczczenia ich zasług;
- zniesiono ostatecznie zastępstwa reprezentacji jakie towarzystwa, nie mogące wysłać własnych delegatów na Sejm, nadawały delegatom innych towarzystw;
- oddano do użytku Polskiej Rady Narodowej w Ameryce fundusze zbierane na Związek Jedności;
- uchwalono dobrowolny podatek na "rzecz obrony Ojczyzny" (zostawiając ostateczną względem tego decyzję poszczególnym towarzystwom);
- wyasygnowano \$1 tys. na powodzian w Galicji oraz \$50 dla sierocińców polskich w Ameryce.

W skład zarządu ZPRKA wybrani zostali: Piotr Rostenkowski - prezes, dr. Antoni Rusin - wiceprezes, Jan S. Konopa - sekretarz generalny, Leon Zamorski - skarbnik, ks. Franciszek Wojtalewicz, ks. Władysław Bobkiewicz i ks. Bolesław Puchalski - kapelani. S. Walkowiak został mianowany adwokatem ZPRKA, dr. Jan J. Nowakowski - lekarzem, Franciszek S. Barć - redaktorem. Dyrektorami zostali: Stanisław Godzich, Teofil Weyna, Józef Pionke, Józef J. Barć, Stanisław Lachajczak, Franciszka Czaja, Marta Żolińska, Franciszek Kiołbassa, Jan Jóźwiak, Jan Świderski, Józef Ruszkiewicz i Władysław Przybyliński. Marja Osuch została reprezentantką spraw kobiecych, a Franciszka Nowakowska - wicereprezentantką.



Konstytucia 3 Maia była pierwsza w Europie. a drugą po Stanach Zjednoczonych konstytucją na świecie. 219 lat temu był to wielki dzień w życiu Narodu Polskiego tak jak i dzisiaj my Polacy nie tylko w Polsce, ale rozsiani po świecie, uroczyście obchodzimy dzień 3-ego Maja jako Święto Narodowe.



Zwykle to święto wypełnione jest radosnymi wiwatami i skoczną muzyką, a w tym roku ze względu na dramat katastofy 10 kwietnia pod Smoleńskiem, obchody miały szczególny charakter. Ta rocznica różniła się od poprzednich, nie było długich przemówień. Zmarły tragicznie prezydent RP Lech Kaczyński i jego żona Maria mieli w planie obchodzić to święto - symbol wolności i niepodległości - razem z Polonią w Chicago.

Uroczystości 3-cio Majowe zaczęły się już w piątek, 30 kwietnia, kiedy to gubernator stanu Illinois, Patrick Quinn, przyjął w swoim chicagowskim biurze przedstawicieli władz organizacji polonijnych, konsula generalnego RP w Chicago, Zygmunta Matynię, przedstawicieli Gwardii Narodowej stanu Illinois oraz specjalnie zaproszonych gości. Spotkanie uczciliśmy minutą ciszy i oddaniem hołdu ofiarom

katastrofy. Gubernator nawiązał w swoim przemówieniu do smoleńskiej tragedii i do Katynia, powiedział, że tegoroczny wypadek, który się wydarzył dotknął i wtrząsnął nami wszystkimi w Stanach Zjednoczonych, w Polsce, jak i na całym świecie. Wspomniał też jak bardzo mieszkańcy stanu Illinois są związani kulturalnie, naukowo i gospodarczo z Polską. Podkreślił także, że polscy żołnierze wspierają Amerykanów w Iraku i w Afganistanie, a od 2003 r. Gwardia Narodowa Illinois współpracuje z polskim wojskiem.

Nastepnego dnia po złożeniu kwiatów pod pomnikiem Tadeusza Kościuszki w Chicago, odbyła się Parada 3-cio Majowa w śródmieściu Chicago. W obchodach wziął udział burmistrz Chicago Richard Daley, prezes Kongresu Polonii Amerykańskiej Frank Spula, konsul generalny RP Zygmunt Matynia oraz lokalni politycy i liczni przedstawiciele organizacji polonijnych wraz z delegacją z Katowic. Hasło tegorocznej parady brzmiało: "Fryderyk Chopin darem Polski dla świata".

W cieniu katastrofy pod Smoleńskiem, tegoroczny pochód rozpoczął się oddaniem hołdu ofiarom, które zginęły 10 kwietnia i uczczenie ich minutą ciszy. Bardzo wzruszający był marsz harcerzy niosących portrety osób, które zginęły w tej tragedii. W całej paradzie było widać biało-czerwone flagi przepasane czarnym kirem. W tym

roku Renee Bober, członkini naszej organizacji, a zarazem tancerka zespołu pieśni i tańca Wesoły Lud oraz choreografka zespołu pieśni i tańca Polanie, miała zaszczyt odśpiewania hymnów na podium przed paradą. W paradzie wzięło udział przeszło 100 polonijnych organizacji, firm i przedsiębiorstw, ponadto dużo polskich sobotnich szkół i zespołów tanecznych. 

Egzamin maturalny zdał w 1955 r. w Liceum Ogólnokształcącym w Radłowie.

W 1956 r. rozpoczął studia i formację w Wyższym Seminarium Duchownym "Hosianum" w Olsztynie, święcenia kapłańskie przyjął w 1962 r. w Olsztynie. Tego samego roku otrzymał nominację na wikariusza parafii Świętej Trójcy w Kwidzynie. W październiku 1963 r. podjął studia na Wydziale Prawa Kanonicznego Katolickiego uniwersytetu Lubelskiego w Lublinie, a 24 lutego 1965 r. wyjechał do Rzymu, by je kontynuować na Wydziale Prawa Kanonicznego Papieskiego Uniwersytetu Gregoriańskiego.

W Rzymie ukończył też kurs kanonicznej praktyki administracyjnej przy Kongregacji Soboru, w 1967 r. podjął współpracę z Sekretariatem Generalnym Synodu Biskupów w Rzymie oraz uczęszczał na studium przy Tajnym Archiwum Watykańskim. W 1968 r. uzyskał tytuł doktora prawa kanonicznego. W tym samym roku rozpoczął Studium w Rocie Rzymskiej, zakończone tytułem adwokata Roty Rzymskiei (1971).

19 grudnia 1969 r. podjął stałą pracę w Kongregacji ds. Dyscypliny Sakramentów. W tym czasie towarzyszył abp. Luigi Poggi, nuncjuszowi apostolskiemu do spraw specjalnych, w podróżach do Polski (1976-1978) i wszedł w skład Zespołu Stolicy Apostolskiej ds. Stałych Kontaktów roboczych z przedstawicielami rzadu PRL. Po wznowieniu 17 lipca 1989 roku stosunków dyplomatycznych między Stolicą Apostolską i Polską został mianowany nuncjuszem apostolskim w Polsce i podniesiony do godności arcybiskupa tytularnego Heraklei. Święcenia biskupie przyjął 20 października 1989 r. w Bazylice św. Piotra z rak papieża Jana Pawła II.

W tym roku, jak nadmienił sam gubernator Pat Quinn, była to rownież bardzo smutna okazja, gdyż uroczystość poświęcona była pamięci prezydenta Lecha Kaczyńskiego, jego małżonce Marii Kaczyńskiej oraz 94 pozostałym ofiarom tragicznej katastrofy samlotowej pod

gubernatora stanu Illinois.

Smoleńskiem. Gubernator przypmniał, że prezydent Kaczyński miał być gościem honorowym tegorcznych obchodów rocznicy Konstytucji 3 Maja oraz wielu uroczystości, które zostały w zwiazku z jego wizyta w Chicago zaplanowane. Dla uczczenia ofiar katastrofy zapalona została świeca, a gubernator poprosił o minutę ciszy.

W swoim dalszym wystąpieniu gubernator Quinn wspomniał, że Konstytucja, która napisana została 119 lat temu w Polsce, była wyrazem narodu polskiego przeciwko wszelkiemu uciskowi, niesprawiedliwości i nierówności społecznej, wyrazem dążenia Polaków do demokracji. Przypomniał również, że Polacy nigdy się nie poddali żadnym przejawom przemocy - czy to ze strony zaborców, Niemców, czy komunistów.

Gubernator wspomniał również o współpracy stanu Illinois z wieloma placówkami w Polsce i z polskim kontyngentem wojskowym stacjonującym w Afganistanie, z którym szczególnie blisko współpracują obecni na uroczystości żołnierze Gwardii Narodowei Illinois. Dodał, iż generał William Enyart, gen. Steven Huber i kapitan Adamczyk, wzięli udział w uroczystościach pogrzebowych przedstawicieli Wojska Polskiego, którzy zginęli w katastrofie samolotwej delegacji RP na uroczystości katyńskie.
