PRCUA ANNUAL STATE OF THE UNION

Dear Members and Friends.

In last year's message, I reported to you that the PRCUA Board of Directors had formed a Corporate Governance Committee to review the method by which the Polish Roman Catholic Union of America is governed and to determine if any changes to this governance should be made.

The Polish Roman Catholic Union of America, as a fraternal benefit company, is subject to the regulations imposed by the National Association of Insurance Commissioners (NAIC). The NAIC is composed of State Insurance Commissioners whose responsibility is to assure the sound management of the respective insurance companies.

Although not presently mandated, but strongly suggested, the NAIC wants to see changes in the top level of EXPENSE and SIMPLIFIED ISSUE - were being successfully accepted management of fraternal benefit societies. Their intended management model is to mirror corporate America by electing directors from the organization's membership. It would then be the directors' responsibility to hire the professional executive management team (President, Vice President, Secretary-Treasurer). The intention is to provide professional leadership through the screening of qualified applicants for the various executive positions. It also provides the ability of the Board of Directors to make changes should the executive officers fail in their respective duties and obligations.

As we know, the PRCUA elects its officers and directors every four years at its Quadrennial Convention. Candidates for office may or may not have the necessary educational or life experiences to properly direct the business, financial, and insurance affairs of the organization. Our Constitution allows anyone who has been a member in good standing for five years, without a criminal record, to be eligible for election.

Since the Great Recession of 2007-08, because of the subsequent slow economic recovery, the increasing demands of state regulatory insurance departments, the increased need to focus on financial markets, the changing demographics and overall challenging business climate, many fraternal organizations have failed and thus have been merged. Much of that failure is due to the fact that the directors and officers did not recognize and adjust to these changing conditions.

For that reason, this Corporate Governance Committee was formed. Questions discussed throughout the year by this Committee and the Board of Directors included:

- Should the PRCUA move away from the traditional form of governance wherein the Executive Officers and Board of Directors are elected every four years by convention delegates at the Quadrennial Convention AND
- Should the PRCUA move to a more formal business form of management by electing Directors and having the Board of Directors screen and qualify candidates for the positions of President, Vice President, and Secretary-Treasurer?
- Should the PRCUA reduce the number of District Directors from 15 to a lesser number, elected-at-large, who are qualified in the insurance and business fields?
- If Directors are elected-at-large, should the PRCUA abolish the 10 governing Districts AND
- Establish a separate Fraternal Governing Board to address the fraternal activities of the organization?
- Should the PRCUA require its elected officials to have a higher education, as well as insurance/finance related work and life experiences instead of the present qualification of being a member for five years and not having a criminal record?

At every board meeting, each of these questions was actively debated.

At the December meeting, the Board of Directors voted to continue the present form of governance wherein the Officers and Directors are elected by convention delegates every four years and to keep the number of Directors or the number of Districts of the PRCUA.

Continuation of this form of governance removes any discussion of a separate Fraternal Governing Board.

The Board of Directors did, however, address higher education, work, and life experience considerations as a requirement of qualification for its elected Officers and Directors.

The additional qualifications for the President, Vice President,

Secretary-Treasurer and Director are outlined on page 12 of this issue of the Naród Polski.

These changes should help to improve the quality of candidates that are chosen to manage and direct our organization.

However, in my opinion, the position taken by the NAIC is the correct one: that the Constitution of the PRCUA must be changed to create a form of governance that adapts to the more complex and demanding business regulatory and insurance industry environment.

Activities and Results of this past year of 2017: **Insurance Sales and Products**

Our Director of Sales, Robert Fattore, after much effort, is successful in engaging the independent agents to represent and sell PRCUA products.

Fraternal and Home Office insurance sales continue on a constant pace but are now exceeded by the growth of sales from the independent

The PRCUA continues to promote and solicit sales from our fraternal agents but the ranks are declining and recruiting new fraternal agents has not been fruitful.

One area that is proving to be a success is the recruitment of Fraternal Field Organizers (FFO). The PRCUA now has three FFOs working in the field promoting our organization. It is a part-time paid position requiring a licensed individual to promote our organization in select geographical areas. FFOs are now working in Georgia, Florida and Grand Rapids, Michigan.

Annuities


The Annuity Rollover Program, initiated in 2016, has been completed. Matured annuity contracts were successfully rolled over into a longer term contract, satisfying regulatory directives. These contracts received a one year above-market rate bonus and then adjusted to the current market rate.

The PRCUA is sensitive to changes in the money and interest rate environment. We are constantly monitoring both our ability to earn a satisfactory return from our asset portfolio and to return a favorable income to our annuity members.

Operating Results

Our operating income for 2017 is reported at \$265,580, down from \$429,757 that was attained in 2016. Unfortunately, a significant reason for this is the decline of approximately \$350,000 in reduced income from our bond and stock investment portfolio. Financial market conditions caused many of our higher-earning bonds to be called away, leaving the PRCUA with excess money to invest at lower interest rates. (Cont. on pg. 5)

Due to a generous donation made by a PRCUA member, the Polish Roman Catholic Union of America is offering an additional scholarship opportunity in 2018. Two \$2,500 scholarships will be awarded to the students with the two highest scoring essays! Essays will be judged by a panel of three educators. Deadline for essay submission -June 1, 2018.

Topic:

The year 2018 marks the centennial of American President Woodrow Wilson's Fourteen Points – the only explicit statement of war aims by any of the countries at war. One of these aims was the reestablishment of an independent Polish state, which was fulfilled with the signing of the Treaty of Versailles in 1919.

Why did President Wilson consider the reestablishment of Poland, bringing a just and lasting peace to Europe, important enough to give Poland its own point within the Fourteen Points? How much did Ignacy Jan Paderewski and the Polish American community influence President Wilson in his decision?

Please submit an application along with an essay on the above topic with a word count between 1,000 and 1,500 words.

Eligibility Requirements:

Applicant must be a member of the PRCUA, in good standing, for a minimum of FIVE (5) YEARS, and have a minimum of FIVE THOUSAND DOLLARS (\$5,000) of life insurance. If, at the time of application, the member does not meet the five year minimum, they may also meet one of the two following standings: THREE YEARS of membership along with \$25,000 in life insurance, or FOUR YEARS of membership along with \$15,000 in life insurance. All qualified members must also be in good standing.

- 1. Applicants must have successfully completed their freshman year of undergraduate studies before the deadline for filing an application. An official transcript or other documentation from the applicant's school must be attached to the completed application form or sent directly by the Educational Institution to the PRCUA on or before the deadline of June 1, 2018.
- 2. Eligible applicants consist of sophomores, juniors, and seniors enrolled full-time in undergraduate study or those students enrolled in graduate or professional degree programs. Full-time enrollment shall conform to those guidelines established by the federal financial aid program. (A minimum of twelve (12) credit hours for day students or eight (8) credit hours for evening students.) Part-time graduate or professional students are also eligible.
- Applicants must have a cumulative grade point average (GPA) of 2.5 or better on a 4.0 scale or 3.5 or better on a 5.0 scale.
- Applicants must keep their insurance policies in effect and in good standing for a minimum of five (5) years immediately following receipt of the last eligible scholarship payment.
- All applicants must be either citizens or permanent residents of the United States.

NOTICE TO CANDIDATES SEEKING PRCUA NATIONAL OFFICES

The Candidates Qualifications Committee has announced that all candidates seeking to run for election to a national office in the Polish Roman Catholic Union of America must contact the Secretary-Treasurer for an application. All applications must be submitted to the Office of the Secretary-Treasurer and postmarked by May 30, 2018.

Candidates must meet the following requirements as set forth by the PRCUA Constitution. Although the Constitution uses masculine terminology, the information applies to males and females equally.

Article 03K Nomination of Officers and Directors

- Only a Delegate meeting the following requirements shall be nominated for the position of Officer or Director for the UNION and may be a candidate for that office in the UNION:
 - the Delegates must personally be present and registered at the Convention within the timeframe of the first session on the second day of the Convention;
 - b. must have been a member of the UNION for at least five (5) years:
 - is a citizen of the United States of America;
 - d. has indicated his desire to aspire for the specified office or his name has heretofore been presented by a Society or a Circuit with the consent of the candidate. Such an announcement must be forwarded to the Candidates Qualifications Committee and postmarked by May 30 of the Convention year. Once approved by the Candidates Qualifications Committee, all qualified candidates must be published in an issue of the official publication of the UNION thirty (30) days prior to the Convention. A candidate for the office of Director must be a resident of the District and he must be a member of a Society, which is located in the District.
- No two members of a nuclear family shall be permitted, during the whole or any part of the same term, to be members of the Board of Directors. Nuclear family shall mean familial relationships only including husband and wife, parent and child and brother and sister. If and in the event that two or more members of a nuclear family shall, at a Convention, run for and receive enough votes to be entitled to be a member of the Board of Directors, then only that member of the nuclear family who has received the most votes from the Delegates at the Convention shall be entitled to take the oath and serve the Term of Office provided for the position for which that member sought election.



PRCUA Annual State of the Union (Cont. from pg. 1)

Hopefully, 2018 will provide better opportunities for higher investment returns.

Other factors affecting our results are the costs related to acquiring new members, i.e. commissions, promotions, new product development etc.

Our dividend declared by the Board of Directors will be \$152,400. This is approximately the same amount as paid in 2016. Our Financial Statements can be found on page 7 of this *Narod Polski*.

Significant Event

A major event for the PRCUA in 2017 was the sale of vacant land owned by the PRCUA. This property was on Walton Street, adjacent to our headquarters. By a majority vote of the Board of Directors, sale of this property and other net realized capital gains amounted to a net gain of \$3,069,256. This profit has been retained and added to our surplus account to provide financial stability for all PRCUA members.

In 2010, this surplus account was at a low point of \$3,600,000. It is now- within seven years - back to the level reported in 2007. As can be seen in the financial statements, our surplus is at \$11,833,894. This will safely provide a necessary cushion for the PRCUA should another financial crisis occur.

I am proud of the action taken by our Board of Directors in approving this sale. It ensures the financial strength and solvency of our Union.

Building Improvements:

Our building is 105 years old and has been in need of extensive improvement for a long time. Over the last seven years, the PRCUA has expended over \$2,000,000 to make these necessary repairs and upgrades. These include:

- A new main entry. After years of ushering guests and visitors into the building through the back service entrance, we have provided, in cooperation with the Polish Museum of America, a formal entrance on Augusta Boulevard leading into a warm, friendly, and sophisticated lobby and reception area.
- We removed every layer of roofing material down to the roof foundation and replaced it with state-of-the-art roofing material.
- We removed the entire crumbling basement sewer system and replaced it with new tiles and sewer materials. Jack hammers were pounding away as we were working in the offices above.
- We had to professionally clean and vacuum the basement to remove the toxic concrete dust that resulted from the repair.
- · We remodeled the offices with state-of-the-art work stations, computers, and carpeting throughout.
- We have, thanks to the efforts of Vice President Misia Jaminski, remodeled all of the first and second floor bathrooms, as well as remodeling the first floor Social Hall and hallways.
- We are presently completing the rework of the building façade with cornices, terracotta, and parapet replacement, tuck-pointing and complete chemical washing and cleaning of the building. This responsibility has been under the direction of Secretary-Treasurer Jim Robaczewski.
- We have installed security cameras and other security features both inside and outside of the building to protect our most valuable assets, our employees and visitors. Entrance into our building is secured. Employees have key passes and all visitors must be electronically buzzed in. Once inside the main lobby, they must identify their purpose and sign the visitor register. We have improved the electrical and lighting systems throughout the building as well as overhauling and rebuilding the elevator that services our building.
- Our computer cyber security system is of the highest caliber, thanks to IT Manager Kevin Ryba. We are very aware of the importance of protecting our member information from hackers. We are doing our very best to prevent illegal access to our personal member files. We have engaged a cyber security firm, on an ongoing basis, to attempt to penetrate our system. Although there is no guarantee of our continuing successful defense, I am pleased that all tests and illegal attempts to enter our system have been stopped. We have also purchased Cyber Security Insurance to protect the PRCUA from financial loss caused by any breach of our files.
- We transitioned our general ledger accounting system to a more reliable computerized method by introducing and converting to the Sage Accounting Program to update our data accountability system. Our Accounting and Audit Manager Emily Kurda was in charge of this conversion. Our IT Manager Kevin Ryba was very helpful in assisting with this change over.
- Our member files, formally kept on paper in 189 separate file drawers, have now been scanned into the computer system for better access, safety, and convenience in serving our member needs. This program involved inputting 56,700 member files, each consisting of anywhere from three to six separate pieces of information. Our Member Services Manager Julie Prado guided this massive effort.
- We have established a separate Marketing Department headed by Agnieszka Bastrzyk. Over the last several years, we have improved all of our efforts in the visual, audio, and written media to more properly convey the PRCUA message to members and non-members alike.
- Our *Naród Polski* publication has been managed very professionally by Executive Editor Lidia Kowalewicz. I am most pleased with the timeliness and quality of the articles, the photo journalism, and the on-time publication and delivery of the newspaper
- As this message is being written, the Executive Committee of the PRCUA is finalizing an agreement with an administrative systems software vendor that will bring to the PRCUA a modern up-to-date system that will allow our members direct access to their own insurance, annuity, mortgage and personal loan information without needing to talk to a member service representative. In addition this system will modernize the internal flow of member information thereby improving the entire administrative process of the PRCUA.

I am proud to state that we have been able to do all of this and still improve the overall financial strength of our Union.

Convention

We call attention to the 2018 Convention to be held on August 10 to 13, 2018 in Dearborn, Michigan. We ask those representative delegates, who will have the responsibility of electing the next governing body of the PRCUA, to closely and carefully review the credentials of all candidates and wisely select those who best represent dedication to the PRCUA and a determination to work toward making the PRCUA the best fraternal organization.

In Closing

It has been my pleasure to have served as your President throughout these past eight years and I sincerely thank you for this wonderful experience. I hope I have fulfilled the objectives that you had expected when you voted for me in 2010 and 2014.

I am stepping down as your President and, although eligible, I will not seek a third term.

FR. ERIC ORZECH IS NAMED "GOOD JOE" BY CLEVELAND SOCIETY

Cleveland, OH - Reverend Eric Orzech, Chaplain and member of PRCUA Society #2220 and a regular contributor to *Naród Polski's* "Higher Perspectives" column, has been named the 2018 recipient of the "Good Joe" Polish-American



Heritage Award by the Cleveland Society of Poles. With the express purpose of preserving and nurturing Polish heritage, traditions, and culture, and to promote the principles of American citizenship, the Cleveland Society of Poles was founded in 1923.

On a quasi-annual basis, the Cleveland Society recognizes an individual member who exemplifies the tradition of service to the community, to the City of Cleveland, and to Polonia. This year, Fr. Eric Orzech has been chosen to receive this award.

Eric Orzech entered this world on March 14, 1967, in Parma, Ohio, the second son of Edward and Helene Orzech, with one older brother, Edward. He was a graduate, with honors, from Benedictine High School in Cleveland. He then entered St. Mary College in Orchard Lake, Michigan, where he received his B.A. degree, also with honors. Fr. Eric completed his priestly studies at St. Mary Seminary, the Diocese of Cleveland's major seminary, in Wickliffe, Ohio in 1993

Ecclesiastically, Fr. Eric received his Ministry of Acolyte in 1988, Ministry of Lector in 1989 and his Candidacy for Holy Orders in 1991.

Fr. Eric spent seminary summers abroad guiding tour/pilgrimage groups at the Pauline Monastery at Jasna Góra in Poland, home to the sacred icon of the Black Madonna "Our Lady of Częstochowa." He became an Ordained Deacon in 1992, was ordained a Priest in 1993 and celebrated his first Mass on May 30, 1993.

Since 2012, Fr. Eric has served as pastor of two Polish parishes: the Shrine Church of St. Stanislaus and the historic re-opened St. Casimir Church, both in the Diocese of Cleveland.

Father's assignments and additional involvement include past-president and chair of the 2007 and upcoming 2018 Convention of the Polish American Priests Association. He also served as chaplain of the Cleveland Society of Poles, president and chaplain of the Ohio Division of the Polish American Congress - and most recently - served on the administrative board of the Pope John Paul II Foundation, headquartered in Rome, Italy.

The "Good Joe Award" is named in honor of St. Joseph. The Award Banquet is always held at a convenient date near his feast day, which is March 19. This year's Banquet and Award Presentation will be held on March 10 at the Tremont City Side Ballroom in Cleveland's Tremont neighborhood.

The Cleveland Society of Poles is considered to be the "elite" organization within Cleveland's Polonia. The organization was founded as a fraternal society of men of Polish descent, engaged in business, the professions, and the arts. Recently, the Society opened its membership to all persons who share its objectives and goals.

The PRCUA offers sincere congratulations and best wishes to Fr. Eric for continued success as a PRCUA member, chaplain, and all-around "Good Joe."





POLISH ROMAN CATHOLIC UNION OF AMERICA BOARD OF DIRECTORS' ACTION TAKEN AT THE PRCUA BOARD OF DIRECTORS MEETING, DECEMBER 1 AND 2, 2017

To all members of the Polish Roman Catholic Union of America in anticipation of the 2018 Quadrennial Convention of the PRCUA to be held in August, 2018:

The members of the Board of Directors Corporate Governance Committee presented recommendations to the entire Board regarding additional qualifications beyond those identified in the Constitution, for candidates seeking the elected positions of President, Vice President, Secretary-Treasurer, and National Director:

For the elected positions of President, Vice President, and Secretary-Treasurer, the Committee recommends:

- Bachelor's degree required
- Post graduate degree preferred
- Minimum of five (5) years as a member of PRCUA and in good standing
- Minimum five (5) years of experience in financial planning, business administration and/or managerial/organizational leadership
- PRCUA Board Certification Training must be completed within six (6) months of installation into office
- Possession or completion of courses for ALMI (Associate Life Management Institute) designation within twenty four (24) months of installation into office.

For the elected position of National Director:

- Bachelor's degree or a minimum of four (4) years of demonstrated life experience or a minimum of five (5) years demonstrated experience in fraternal activities
- Minimum of five (5) years as a member of PRCUA and in good standing
- PRCUA Board certification training must be completed within six (6) months
 of installation into office
- Possession or completion of courses for ALMI (Associate Life Management Institute) designation within twenty-four (24) months of installation into office

This recommendation of the Corporate Governance Committee was approved by the Board with notification to be made as soon as possible to the PRCUA membership.

In addition to the duties of elected positions as stated in the PRCUA Constitution, the Committee identified specific responsibilities that candidates for each office must consider:

Responsibilities of the President:

- Participates in the investing of funds of the organization
- Represents the PRCUA at national and local events
- Develops and implements the Business Plan
- Oversees Compliance, Investments, Human Resources, and General Counsel

Responsibilities of the Vice President:

- Oversees Sales, Marketing, Fraternal and Publications Departments
- Represents the PRCUA at national and local events

Responsibilities of the Secretary-Treasurer:

- Oversees Information Technologies, Member Services, Risk Management, Auditing, Treasury, Underwriting, and Building and Property Management
- Represents the PRCUA at national and local events

Responsibilities of the National Director:

- Required to participate in all scheduled Board meetings
- Monitors fiduciary activities of PRCUA and Executive Committee
- Main contact in resolving issues between Home Office and local Districts
- Actively promotes and/or organizes local organization functions
- Promotes and solicits membership
- Represents the organization in local and national events

NOTE: Board certification and all ALMI course costs are paid for by the PRCUA.

If there is no qualified candidate for an Executive Officer or Board of Director position, the Board of Directors reserves the right to solicit and elect an individual for the position.

If an Officer or Director fails to pass the OLM, ALMI or Insurance Producer's license within the designated time, the Board of Directors will declare a vacancy.

A.M.D.G. - "MARCH"ING

An oxymoron! This Lent of 2018, Ash Wednesday fell on Valentine's Day. How could we freely celebrate LOVE on such a solemn day?

The fact is that it is love that we celebrate, in a special way, beginning on Ash Wednesday. So THIS IS LOVE – Jesus, God Himself taking on human form, born poor, living in a family, enduring trials, temptations and doubts, and dying . . . just like us! Like us, He never wanted suffering, sorrow, rejection, abandonment. For Jesus, love was taken to the extreme. He totally submitted to the Will of the Father in offering Himself. We take our cue from Him on "how to do it."

So, how do we get closer in our lives to this perfect model - Jesus? The month of March gives us a clue – we can start "march"ing. We are marching to Pretoria...Hoorah!"

Second Group of Honorees Inducted into Polish Women's Hall of Fame

Hamtramck, MI - The Piast Institute inducted the second set of remarkable women into the Polish Women's Hall of Fame on September 1, 2017. Women were selected in all six categories featured in the Hall of Fame. The honorees are:

Science and Education: Stephanie Louise Kwolek (1923-2014) is the inventor of Kevlar. After finishing a Bachelor of Science degree at the Margaret Morrison Carnegie College of Carnegie Mellon University in 1946, Kwolek accepted a position at DuPont where she became involved in polymer research. She is the only woman to have been awarded DuPont's Lavoisier Medal for her achievements. She has also been recognized by the National Inventors Hall of Fame, the American Institute of Chemists, the American Chemical Society, the National Women's Hall of Fame, and the Royal Society of Chemistry in the United Kingdom.

Arts and Humanities: Magdalena Abakanowicz (1930-2017) was an artist. While Abakanowicz began her career as a painter in Poland in the 1950s, she is best known as a sculptor. Her most famous works are headless human forms made from sacking stiffened with glue and resin, which are fitted over steel frames. Her work has been displayed all over the world. Her most famous installation in the United States is Agora, a set of 106 iron figures on display in Grant Park in Chicago, Illinois.

Religion: Blessed Mary Angela Truszkowska (1825-1898) is the founder of the Felician Sisters. Interested since childhood in serving people in need, Truszkowska became a member of the Society of St. Vincent de Paul as a young woman. She worked among the poor and aided with the religious education of abandoned children. In 1855 she dedicated herself and founded the Congregation of the Sisters of St. Felix of Cantalice—the Felician Sisters. The Order grew, both under her direction and after her retirement, sending its first five Sisters to America in 1874. She was beatified in 1993.

Public Life and Service: Antonina Żabińska (1908-1971) was the subject of the book *The Zookeeper's Wife*, who helped shelter many Jews in the Warsaw Zoo during the Nazi occupation of Poland by offering them food and temporary quarters. Żabińska continued her humanitarian work by aiding survivors who remained in Warsaw's ruins after the Warsaw Uprising, despite the deportation of her husband as a prisoner of war. She was also the author of several children's books written from the perspective of animals. She, along with her husband, has been recognized as Righteous Among the Nations by Yad Vashem.

Sports: Jenny Romatowski (1927-2014) played on several teams of the All-American Girls Professional Baseball League. In addition to her four years—and 1954 championship—with the Kalamazoo Lassies, she also played with the South Bend Blue Sox, the Rockford Peaches, the Chicago Colleens, the Racine Belles, and the Peoria Redwings. She was a member of the All-Star Teams of 1952 and 1953. She was also a member of the U.S. national team of the 1959 World Field Hockey Tournament, and vice president of the U.S. Field Hockey Association. She has been honored by the National Polish American Sports Hall of Fame, the Eastern Michigan University Hall of Fame, and the Michigan Amateur Sports Hall of Fame.

Philanthropy: Valeria Lipczynska (1846-1930) was a cornerstone of the Polish community in Grand Rapids, Michigan in the late 19th and early 20th centuries. Lipczynska and her husband arrived in Grand Rapids in 1869, and helped at least forty other Polish families settle in the area. She was instrumental in the organization and establishment of a variety of Polish American organizations in the Grand Rapids area. She also helped immigrants establish themselves and find employment, supported the arts, and served as a correspondent for Polish newspapers in the Midwest. She was the first woman to serve on the Board of Directors of the Polish National Alliance. She received the Polish Golden Service Cross for her work with immigrants in 1927.

The first honorees were inducted in March 2017, when the project was officially launched. The Polish Women's Hall of Fame is a virtual exhibit hosted at www.FamousPolishWomen.com. The project seeks to raise awareness of women's contributions to the culture and history of Poland and the world by offering biographical profiles of notable women and historical information. It also seeks to honor the impact that less famous local women have had on countless individuals' lives through the *A Woman to Remember* page.

The Polish Women's Hall of Fame has two selection cycles each year, with new honorees announced in March and September. Nominations are accepted from the public through January 1 for the March selection cycle and through July 1 for the September selection cycle. Members of the public are encouraged to submit nominations using the forms available, in English and in Polish, on the project website. Completed forms may be submitted online, by email, or by mail.

The A Woman to Remember page accepts nominations on a rolling basis, and is intended to honor the contributions of women—mothers, sisters, friends, teachers, and so many more—to the life of the nominator. These stories are not subject to review by the Selection Committee, and the women are not formally inducted into the Hall of Fame—instead, stories are posted when they are received and are intended to reflect a range of personal accomplishments and experiences.



POLISH EASTER FAVORITES

Easter Rahka

1/2 cup sugar, 1/3 cup milk (warm), 2 compressed yeast cakes (or two envelopes of active dry yeast), 1/4 cup flour, 3-1/4 cups flour, 6 eggs, 4 egg yolks, 1-3/4 sticks of melted butter that has been cooled, 2/3 cup raisins, pinch of salt, liquid fruit jam or icing for decoration

In a small glass bowl, dissolve the yeast in warm milk. Add 1 Tbsp. sugar and 1/4 cup of the flour. Set aside for 30 minutes in a warm place so the yeast can rise. In a medium bowl, mix the rest of the sugar, eggs and egg yolks, and the remaining flour; mix well. While mixing, add melted butter a little at a time. Then add a pinch of salt and raisins; mix. Grease babka mold(s) with butter and sprinkle with flour. Place the dough into mold(s), filled to no more than half as it will rise before and during baking. Put it in a warm place to double the volume. When sufficiently risen, preheat oven to 350°F and bake for 45 min. or until a toothpick inserted near the center comes out clean. Cool on a wire rack, Drizzle icing made by whisking together confectioners' sugar, lemon juice, and boiling water or decorate with liquified fruit jam.

Potato and Horseradish Soup

Horseradish is an indispensable addition to Easter meats and cold meats, but it can also be used to prepare an aromatic, creamy soup. 1/2 cup chopped onion, 1 Tbsp. butter, 1/2 cup white wine, 1-1/2 quarts vegetable broth, 1/2 cup red potatoes; peeled and diced, 1 chopped clove of garlic, 1/2 cup thick sour cream, salt, white pepper, nutmeg, lemon juice, 4 Tbsp. of freshly-grated horseradish, 8 thin slices of smoked bacon, 8 very thin slices of stale country bread

Cook the onions in butter until translucent, add wine and broth, then add the potatoes and garlic, cook for 20-30 minutes. In a cup, mix the sour cream with a little of the hot soup, pour it back into the pot, mix and cook for 2 min. but do not bring to a boil. Season to taste; add horseradish and mix. Put bacon and bread on a baking tray and bake at 300°F, until both are crispy. Add a slice of toast and a slice of crisp bacon into each bowl before filling it with soup.

Fresh Polish Kiełbasa Baked with Apples and Onions


1 lb. uncooked, unsmoked Polish sausage, 3 apples, 2 large onions, 1 cup apple cider, 1 Tbsp. brown sugar, 1/2 cup raisins, juice from half a lemon, 1 Tbsp. oil, salt, coarsely ground black pepper

Place sausage in a pot, cover with cold water. Cook on medium heat until the water almost boils - but it should not boil. Turn off the heat, leave the sausage in the water and cool for about 15-20 minutes. While the sausage is cooling, peel onions and cut into eights. Heat oil in a frying pan, add the onions, fry stirring gently, let the onions burn. Remove from the pan and put aside. Peel the apples and cut them into eights, remove the seeds, sprinkle with lemon juice. Place sausage in a baking dish, add onion, apples and raisins, pour the cider over the sausage, sprinkle with coarsely ground pepper and brown sugar. Preheat oven to 350°F. Bake for 30 minutes, then increase the temperature to 400°F degrees and bake for another 10 minutes. Serve with ćwikła (grated red beets mixed with horseradish.).

Quail Eggs with Sauce

10 quail eggs, 2 dill or brine pickles, 2 Tbsp. plain yogurt, 2 Tbsp. mayonnaise, 2 Tbsp. canned green peas (drained), 6 marinated mushrooms (drained), salt and pepper to taste.

Boil the eggs for 4 minutes; cool with cold water. Peel eggshells and slice eggs in halves. Dice mushrooms and pickles finely, add yogurt, mayonnaise and peas; mix together. Season with salt and pepper and mix. Place the sauce on a plate and arrange halved eggs on top of the sauce.

Po mszy, Kościuszkowcy wraz z pocztami sztandarowymi przeprowadzili gości i uczestników do budynku szkoły katolickiej. Tam na sali gimnastycznej, pięknie udekorowanej na tą okazję pracami uczniów ze Szkoły św. Jana Pawła II, rozpoczęła się główna akademia z uhonorowaniem Polaków Roku 2018 i programem artystycznym. Burmistrz miasta Lemont pan John Egofske, wręczył prezesowi Klubu Polskiego Ryszardowi Witkowskiemu Proklamację Dnia Polskiego.

Klub Polski w Lemont, który od 1979 roku prężnie i czynnie działa w tej miejscowości, jest organizacją powstałą przy kościele śś. Cyryla i Metodego w Lemont, IL. Założycielami klubu byli Polacy mieszkający w Lemont i okolicach, a iniciatorem i osoba, która dała im pomysł był (już ś.p.) ksiądz Edward Witusik. Początkowo klub miał dwa cele: pierwszym było doprowadzić, aby w kościele śś. Cyryla i Metodego odprawiała się msza święta w języku polskim dla coraz liczniejszej Polonii w tych okolicach, a drugim celem było założenie szkoły polskiej, gdzie dzieci z polskich rodzin mogłyby się uczyć języka polskiego, historii i geografii Polski. Obydwa cele udało się osiągnąć. Obecnie, w kościele są odprawiane w każdą niedzielę, dwie msze święte w języku polskim, jest spowiedź święta po polsku, czuwania pierwszosobotnie, nabożeństwa Maryjne w każdy wtorek, rekolekcje bożonarodzeniowe i wielkopostne oraz od dwóch lat mamy religię, prowadzoną przez polskich katechetów z polskim językiem głównym i angielskim w miarę potrzeby. Od 1980 roku działa Szkoła Polska im. św. Jana Pawła II, która zaczynała naukę dla 60 uczniów, a obecnie uczeszcza do niej ponad 400 dzieci. Od wielu lat uczniowie szkoły są członkami ZPRKA, która to organizacja wspiera szkołę w różnych uroczystościach, a główna pomoc idzie na kółko taneczne "Polanie". Tancerze uczą się tańców z różnych regionów Polski oraz co parę lat uczestnicza w festiwalu tanecznym organizowanym w Polsce. Uczniowie mają możliwość nauki w wieczornych zajęciach piątkowych lub rannych w każdą sobotę. Co roku, są organizowane wycieczki do Polski dla klasy ósmej i maturalnej, które naocznie przybliżają dzieciom już urodzonym w USA Polskę, jej tradycje, kulturę, architekturę, sztukę i życie Polaków w obecnych czasach.

W roku 2004, ówczesny prezes Klubu Polskiego Ryszard Witkowski, zaproponował zorganizowanie Dnia Polskiego. Głównym celem tego pomysłu było pokazanie historii Polski, jej kultury, tradycji, współczesnych osiagnięć Polski dla społeczności amerykańskiej. Również w tym dniu co roku Komitet Organizacyjny Dnia Polskiego wybiera Polaka lub

Polaków Roku. Mamy wspaniałych Polaków, którzy swoją praca, postawa i dorobkiem potrafia dzielić się z innymi, a przy tym potrafią zachować tożsamość polską i przekazywać ją następnym pokoleniom. W Lemont i okolicy nie znajdziemy większego patrioty Polaka niż pana Kazimierz Cisło, a jego żona Kazimiera, jest przykładem dla każdej matki i babci w wychowaniu patriotycznym, moralnym i polskim swoich dzieci.

Obchodzona w tym roku 100. rocznica niepodległości Polski jest wspaniałą okazją do pokazania młodemu pokoleniu oraz Amerykanom, tej naszej trudnej, czasami niezrozumiałej ale przepełnionej nadzieją i miłością do Ojczyzny Polski, drogi czterech pokoleń Polaków do uzyskania niepodległości przez

W tą niedzielę, 18 lutego 2018 roku, członkowie Klubu Polskiego, wcielając się w historyczne już postacie Polaków, jak: Helena Modrzejewska (Helena Gudzowski), Marja Konopnicka (Małgorzata Snieżko), Józef Piłsudski (Jan Zoltek), Ignacy Paderewski (Ryszard Witkowski), Roman Dmowski (Jan Stefański), prezydent Woodword Wilson (Mirek Cisło), babcia (Anna Zoltek) z wnukiem (Darek Kwak) przy pomocy dzieci i tancerzy z kółka tanecznego Polanie, z Polskiej Szkoły im św. Jana Pawła II, pokazały publiczności trudną drogę Polski do niepodległości. Dzięki życzliwości dyrektora zepołu tanecznego "Polanie" i zarazem głównego choreografa, pana Ryszarda Jamińskiego, tancerze wystąpili w strojach Księstwa Warszawskiego oraz z czasów zaborów. 


